**Title: HPCON BRAVO+**

Task Organization: IAW JBER ICC Plan 01 August 2019.

1. (U) Situation. The installation will transition to Health Protection Condition (HPCON) BRAVO+. My priorities remain 1) protect our military and civilian personnel and their families; 2) safeguard our national security capabilities; and 3) support the whole-of-nation response to the pandemic. Our Service Members and on-base community may question why JBER is not following the State of Alaska and Anchorage easing restrictions. JBER's approach will purposely lag local government easing measures as we continue to track disease trends, and monitor both our testing and health care capacity.

2. (U) Mission. 673<sup>rd</sup> ABW commanders will execute responsible mitigation plans NET 260500MAY2020 to transition to more available services and operations and disseminate the HPCON change throughout their units in order to maintain mission required functions and activities while responsibly reopening services across the installation.

3. (U) Execution.

a. (U) Commander's Intent. Continue operations and control/contain the spread of COVID-19 on JBER.

b. (U) Tasks to 673 ABW Command Teams and Staffs.

(1) (U) JBER Commanders

(a) (U) IOT restore JBER services by HPCON actions directed under BRAVO+, prepare mitigation efforts and receive approval from the CC of the mitigation plan to restore services. Update Services by HPCON spreadsheet on the NIPR VOC NLT COB 26 May 2020.

(b) (U) Be prepared to transition back to HPCON CHARLIE if risk metrics data show worsening conditions.

(c) (U) Ensure that the workforce continues to make decisions in line with the DoD priorities of protecting our Service Members, DoD civilian employees, and their families from COVID-19, and safeguarding our national security capabilities. Continue to strongly promote self-discipline by complying with restrictions and mitigation controls and summarized in Attachment A.

(2) (U) As directed, 673 ABW/PA will disseminate information on JBER services with reference to HPCON BRAVO+ actions via all communication platforms.

### d. (U) Coordinating Instructions.

(1) (U) Employees will be required to return to workplaces subject to command and supervisor determinations. Use of telework when possible for those whose physical presence is not required and when it supports the mission should be maximized. Commanders must also reduce employee exposure to others through physical separation, while maximize use of both shift-based and flexible schedules when possible.

(2) (U) Personnel will follow State and local directives to the maximum extent practicable while engaged in activities off-installation. All personnel are expected to be familiar with the State of Alaska's current Health Mandates (<https://covid19.alaska.gov/health-mandates/>) and respect any guidelines or restrictions imposed by local businesses. Continued self-discipline in these challenging times serves as the cornerstone to defeating the virus and force preservation.

(3) (U) Status of JBER Services spreadsheet is posted on the NIPR Virtual Operations Center (VOC), COVID-19 link, in the JBER Services by HPCON folder at: [https://intelshare.intelink.gov/sites/jointbaseelmendorfrichardson/Virtual\\_Exercise/\\_layouts/15/start.aspx#/SitePages/Home.aspx](https://intelshare.intelink.gov/sites/jointbaseelmendorfrichardson/Virtual_Exercise/_layouts/15/start.aspx#/SitePages/Home.aspx)

(4) (U) All CDC and DoD guidelines will be followed to include face covering and travel guidance. Vulnerable individuals (e.g. elderly, underlying health conditions, respiratory disease, immunocompromised, etc.) should continue to shelter in place when possible.

(5) (U) There will be no indoor gatherings of more than 25 people without an exception to policy. Maximize ventilation during indoor gatherings and use outdoor venues when possible.

(6) (U) Outdoor gatherings that exceed 25 people require commander's approval and mitigation efforts to protect the force. These mitigation efforts should include focusing on social distancing at choke points, entrances and exits to venues where personnel might congregate and be exposed to additional risk.

(7) (U) Physical distancing of six-feet will be maintained outside of household members.

(8) (U) Symptomatic persons under investigation (PUI) will be isolated.

(9) (U) Persons with confirmed COVID-19 test will be isolated until cleared by public health.

(10) (U) The JBER Installation Commander Memorandum, "14-Day Self-Quarantine," March 29, 2020 remains in effect requiring personnel to immediately go into a 14-day self-quarantine upon arrival into Alaska.

(11) (U) JBER Installation Commander Memorandum, "Temporary Installation Access Restrictions", dated 24 Mar 20 is rescinded however **Trusted Traveler access to the installation remains suspended.**

(12) (U) JBER Installation Commander Memorandum, “COVID-19 Installation Guidance for Wear of Cloth Face Coverings”, dated 10 Apr 20 **remains in effect**.

(13) (U) JBER Installation Commander Memorandum, “Temporary Relaxation of Hair Grooming Standard,” March 23, 2020, **is rescinded on 2 JUN 20**.

(14) (U) JBER Installation Commander Memorandum, “Sanitation and Cleaning for all Face-to-Face Customer Service Ares Policy,” March 18, 2020, **remains in effect**.

(15) (U) DoD stop movement is still in effect until 30 JUN 20.
