UPCOMING ARMY EAS & EIS

BAX/CACTF Environmental Impact
Statement – USAG-AK continues to work
on the EIS for the Battle Area Complex
and Combined Arms Collective Training
Facility (BAX/CACTF), two new large
training facilities proposed for
construction at Donnelly Training Area.
The EIS should be available for Tribal,
agency, & public 45-day review in Nov.
2004.

33-Mile Loop Environmental Assessment - USAG-AK is proposing to upgrade the Muskeg Hill segment of 33-Mile Loop Road at Donnelly Training Area (DTA), Alaska to provide access for more training opportunities east of Jarvis Creek at DTA. DTA is the main location for larger-sized military collective training in Alaska. The Proposed Action would allow year-round access to Jarvis East and Granite training areas.

Maneuver Corridor Environmental Assessment - USAG-AK is proposing to develop an Arctic Warrior Maneuver Corridor in 2005 on Ft. Richardson to provide additional mounted maneuver training area. The corridor would give commanders multiple training scenario options, like airdrops, practicing perimeter security around drop zones, Stryker safety danger area crossing, live fire from firing points 3 through 6 and McLaughlin/ MK-19 Range, and incorporating and practicing freeing disabled or stuck vehicles at a small portion of wetland area before concluding the scenario and/or combining corridor activities with training on the Infantry Platoon Battle Course or surrounding training areas.

SIGNING CEREMONY AT NATIVE VILLAGE OF EKLUTNA

On August 4, 2004, Native Village of Eklutna (NVE) hosted a ceremony to celebrate the signing of a Memorandum of Agreement (MOA) between the U.S. Army Garrison, Alaska (USAG-AK) and NVE. formalizes The agreement Government-to-Government relationship between NVE and USAG-AK and also covers cooperative relationships conducting research to provide optimal management of natural and cultural resources on public lands on Fort Richardson. Colonel Donna Boltz, USAG-AK Garrison Commander, stated that "this is a smart agreement that enables us to work together on matters of mutual interest in a thoughtful and respectful way." The Eklutna Tribe is, by proximity, often impacted by many training and environmental issues, and has an interest in Fort Richardson, which covers part of their traditional territory.

FT. WAINWRIGHT FIELD TRIP FOR TRIBAL LEADERS & REPRESENTATIVES

On September 23, 2004, tribal leaders and representatives from Interior Alaska met Amanda Shearer at the front gate of Fort Wainwright to participate in a field trip of Army training facilities on the base.

The first stop was at the Terry L. Wilson Battle Command Training Center (BCTC), which is a state-of-the art facility designed as a key resource in transforming the Army at war. The BCTC conducts Battle Staff training for the U.S. Army Alaska, providing trained and ready combat units to support current and future global operations.

The second tour was held at the PVT Martinez Combined Arms Collective Training Facility (CACTF), a 15+ acre site that includes 17 structures augmented with a sports field, underground trainer, 4 landing/pick-up zones, and city clutter. The CACTF enables soldiers to develop the skills and unit cohesiveness necessary to conduct clearing, breaching, offensive and defensive operations in a realistic, urban environment.

As the afternoon proceeded, various Garrison staff gave presentations to the group. Steve Reidsma described how Fort Wainwright and other Army managed lands can be accessed by the public for recreation. Cristal Fosbrook provided an update on the status of Army activity at Gerstle River. Julie Raymond-Yakobian gave a presentation on how archaeology is done on Army managed lands in Alaska.
