

**1. CURRENT BAVARIAN ORDINANCE (Bav. Ord.)** In the State of Bavaria, the 13th Bavarian Ordinance containing COVID-19 restrictions was originally enacted on **5 June 21** and is effective **7 June 21** through **4 July 21**.

**2. INFECTION RATE-BASED SCHEME. (Bav. Ord., Part. 2).** Bavaria's restrictions are based on the 7-day incidence of new infections per 100k residents in individual districts and cities expressed as XX/100k. That rate determines limitations on gatherings and business operations. However, most of these restrictions do not apply to persons who show proof of full vaccination.

**a. Below 50/100k.**

- Private gatherings at a home or in a public space are permitted up to a maximum of 10 persons, (no limit on number of households). Fully vaccinated persons / children under 14 do not count.
- "Planned special events" with a specific invitation list and contact tracing, such as a wedding reception or similar event, are permitted with up to 100 persons outdoors or 50 indoors. Indoor events require a mask. Fully vaccinated persons do not count.
- Outdoor cultural and sporting events which require a ticket for admission are permitted with up to 500 persons. All must have an assigned seat and wear a mask.
- There are no limits on participation in outdoor sporting events or PRT.
- Indoor dining is open without restriction; all must follow hygiene and social distancing rules.
- All stores are open, but masks are required. Patron numbers are limited based on space.
- Hotels are open; proof of vaccination or a negative test required at check-in.
- Day care is open without restriction; all must follow hygiene and social distancing rules.
- No curfew; alcohol may be banned in public areas, stay alert to signage.

**b. Between 50/100k and 100/100k.**

- Private gatherings at a home or in a public space are permitted up to a maximum of 10 persons, but from no more than 3 households. Fully vaccinated persons / children under 14 do not count.
- "Planned special events" with a specific invitation list and contact tracing, such as a wedding reception or similar event, are permitted with up to 50 persons outdoors or 25 indoors. All must have proof of vaccination or a negative test. Indoor events require a mask. Fully vaccinated persons do not count.
- Outdoor cultural and sporting events which require a ticket for admission are permitted with up to 500 persons. All must have an assigned seat and wear a mask. All must have proof of vaccination or a negative test.
- There are no limits on participation in outdoor sporting events or PRT, but all must have proof of vaccination or a negative test. Contact-free sports in groups of up to 10 persons or outdoor in groups of up to 20 children under the age of 14 are permitted without proof of testing.
- Indoor dining is open, but proof of vaccination or a negative test is required when more than 1 household will share a table. All must follow hygiene and social distancing rules.
- All stores are open, but masks are required. Patron numbers are limited based on space.
- Hotels are open; proof of vaccination or a negative test required at check-in and every 48 hours.
- Day care is open with limits on numbers; all must follow hygiene and social distancing rules.
- No curfew; alcohol may be banned in public areas, stay alert to signage.

**c. Above 100/100k.** Only one household and one person from another household may gather. Fully vaccinated persons do not count. Shops, restaurants, and other establishments may return to emergency rules. A nighttime curfew is in place from 2200-0500 only when rates exceed 100/100k.

**3. RELIGIOUS SERVICES (Bav. Ord. § 8).** Singing is permitted by all, but must wear a mask. If case rate goes above 100/100k, congregational singing is forbidden.

**4. FFP2 Mask Requirement (Bav. Ord. §§ 3, 8, 10, 14, 15).** FFP2 Masks are mandatory for persons age 16 and over in public transportation, retail outlets, religious services, and restaurants when not seated. Children age 6 - 15 must still wear a regular "community mask" on public transport and in shops.
