## Transfer, Sell or Give POV to another ID Cardholder:

- Valid ID Card
- Valid U.S. Forces Certificate of License or Temporary US Forces Certificate of License
- Active / Valid registration (AE Form 190-1A)
- Buyer and Seller MUST be present (if under joint or co-ownership, both owners must be present)
- Buyer needs insurance confirmation card (ICC). (See checklist #14)
- passed Inspection (not older than 30 days) is required if:

**Current registration expires within  
60 days**

- Lien release if required, a clear title, or a lien satisfaction letter specifying the vehicle's year, make, model, and chassis number.
- POV Waiver if required
- Per AE Regulation your limit of POVs registered is:
  - Single or Unaccompanied:      2 POVs and 1 Recreational
  - Married/Accompanied:          3 POVs and 2 Recreational
- \$ 45.00 Credit / Debit Card or Check / Money Order made payable to "USAREUR Registration Fund"
- **NOTE:**
  - Any customer registering their 1st POV in USAREUR Vehicle Registration system, must provide a copy of orders or memorandum from human resources verifying logistical support. Contractors require the blue SOFA Card and logistical support.
  - Registration of a POV in the USAREUR Vehicle Registration system requires the SPONSOR to be present or Power of Attorney (POA) for the spouse. If a special POA is presented, it must be specific to the vehicle being registered.

Please ensure all mandatory items listed above are present when conducting your transaction.

**Block A:** Filled out by the buyer please provide your full CMR address.

**Block B:** Filled out by seller; if there is a joint owner, BOTH must print names and sign.

**Block C:** Filled out by Registrar must be stamped to make it official.
