## INSURANCE

---

Prior to scheduling an appointment with Vehicle Registration, you should contact your insurance company and verify you have international coverage or inform them you need coverage in Germany.

Currently only two U.S. insurance companies provide electronic insurance confirmation with the USAREUR Vehicle Registration System. You should ask your insurance company if they have electronic confirmation capability with the United States Army Region Europe (USAREUR) vehicle registration system. For insurance companies without electronic capability with the USAREUR system, you must have an Insurance Confirmation Card (ICC) in hand. The ICC is sometimes referred as a "Double white card".


An ICC from an authorized insurance company is the only acceptable proof of insurance for registration in the USAREUR system. Every time a vehicle is registered or reregistered with new license plates an insurance confirmation card (ICC) must be submitted. Green international insurance documents or the German EVB Number (Elektronische Versicherungsbestaetigung) will not be accepted as proof to register a vehicle.

The insurance must be in effect at the time of registration. ICCs must show an issue date that is less than 120 calendar days before of application. ICCs with future effective date will not be accepted. The name on the ICC must match the name of the registered owner.

A new insurance card is required any time plates are changed. For local companies this is a referred as a "Double white card or Blank insurance card", meaning it has no license plate information indicated.
