SUBJECT: Monitoring Compliance with USAREUR Policy for Motorcycle Operators
and Passengers to Wear Reflective Apparel

This memorandum expires in 1 year.

1. References:

a. Memorandum USAREUR, AECS-S, 27 June 2013, subject: Motorcycle Safety:
Reflective Apparel for Motorcycle Operators and Passengers.

b. AE Regulation 190-1, Driver and Vehicle Requirements and the Installation
Traffic Code for the U.S. Forces in Germany.

2. Reference 1a clearly prescribes the requirements for motorcycle operators and
passengers to wear reflective clothing. At all IMCOM-Europe United States Army
garrisons, contract security guards (CSG) and the military police (MP) will comply with
the following instructions, which are in accordance with the scope of the respective
statement of performance or contract work statement to enforce the requirements in
reference 1a.

a. **CSGs.** CSGs will assess motorcycle operators and passengers for the proper
reflective apparel when checking ID cards. If an operator or passenger is not wearing
the proper reflective apparel, the CSG will inform the operator or passenger that he or
she is not in compliance with USAREUR's motorcycle safety policy. The CSG will then
record the name of the individual and the time of the encounter. At the end of the shift,
the CSG supervisor will provide the information to either the MP desk sergeant or the
POC designated by the garrison provost marshal.

b. **MP.** If the violator is a—

(1) Servicemember, a DOD civilian or contractor employee, or a Family member,
the MP will provide the name, date and time, and the location of the infraction to the unit
commander or civilian supervisor to follow the suspension and revocation procedures
for traffic-code violations delineated in chapter 2, section II of reference 1b for incidents
in Germany or other specific licensing regulations for incidents in the Benelux and Italy.

(2) Host-nation citizen, the MP will take no further action.

(3) NATO member state Servicemember, the MP will provide the name, date and time, and the location of the violation to the individual's chain of command for appropriate action.
