Deploying Military & Civilians

Military personnel deployed to designated hostile-fire areas or on operational deployments may place their POVs in Government-approved storage and have their POV registrations suspended for the period of deployment.

Deployed U.S. Forces personnel (verified with deployment orders or a memorandum from the rear detachment commander confirming deployment) may add a non-Family member as an additional driver to their vehicle registration for the purpose of vehicle care using a special POA. The non-Family member added as an additional driver must be a member of the U.S. Forces or the civilian component with full individual logistic support and must be removed from the registration once the owner returns from deployment.

- Registration status must be active. Vehicles with expired registrations (for any reason), temporary plates and export plates (QQ) do not qualify and cannot be accepted into storage.
- Only POVs with an active permanent registration (German Style License Plates or Active NON-Operational Registrations) can be placed into storage status.
- The validity of the current USAREUR vehicle registration MUST be verified by the command prior vehicle being accepted in storage.
- POVs MUST be stored under a lock and key and cannot be accessed by the general public.
- Any Vehicles found outside of the storage facility can have action taken against them by Military or Host Nation Police.
- Once all the vehicles have been placed in storage, the command shall email a POV Storage for deployed personnel memorandum and Deployment Orders to our customer service at: usarmy.sembach.usareur.list.rmv-cust-svc@army.mil (See example on Page 2)

NOTES:

Soldiers must be briefed that POVs will be released to them upon their return without first providing a new Insurance Confirmation Card (ICC) to the vehicle registration office and being provided a new registration document with their new expiration date and marked with **RETURN FROM DEPLOYMENT**.

POVs that will be driven while the owner is deployed must continue to be registered (renewed), insured, and inspected when required.

If a POV is left with a spouse, do not place it in storage or on the storage memorandum. If the spouse is listed as an additional driver, a special power of attorney will be required in order for the spouse to perform any vehicle transactions (i.e. renew registration). It is recommended to add the spouse a joint owner prior to deployment.
