# Appointing an Agent to Operate, Ship, Sell or Dispose of a POV:

## Owner and Agent Owner must be present! Agent MUST be higher Rank/Paygrade than Owner.

#### **Owners Checklist:**

- Valid ID Card
- Valid SOFA Card (Contractors only)
- Valid US Forces Certificate of License
- Valid USAREUR Registration (Must have at least 90 days left; If not must be inspected first and renewed)
- BOTH Owner and Agent must be present (Agent needs to be one Rank higher than the owner!) \*\*JOINT Owners must Both be present\*\*
- Agent Duty Appointment Memo from the Commander (Visit USAG Bavaria webpage for Example)
- Letter of authorization from Lien Holder to add an Agent
- \$45.00 Credit / Debit Card or Check / Money Order made payable to "USAREUR Registration Fund"

#### Agent's Checklist:

- Valid ID Card
- Valid SOFA Card (Contractors only)
- Valid US Forces Certificate of License
- POV waiver, if this transaction causes agent to exceed vehicle allotment

#### NOTES:

- Insurance must remain active in owner's name until POV is shipped or sold.
- A copy of your orders, Memorandum from Human Resources or a Contract is required to register your first car in the USAREUR system.

Please ensure all mandatory items listed above are present when conducting your transaction.
