## US Army Retirement Process Guide

This comprehensive guide outlines the key steps for US Army personnel preparing for retirement. ### Step 1: Request and Review Retirement Documents

### Step 2: Submit Retirement Application via IPPS-A PAR

Once you receive your DA7301/DA2339 (Service Computation) from the Transition Center, you'll need to submit your retirement application to the Human Resources Command (HRC) through the Integrated Personnel and Pay System - Army (IPPS-A) Personnel Action Request (PAR).



# Step 3: Request Separation Orders and DD214 Worksheet

After HRC approves your retirement request, you must take action to obtain your separation orders and DD214 Worksheet. These documents are critical for your transition out of active duty.

### **Required Documents**

- HRC approval message or PCRN number
- Approved Permissive PTDY leave (TAA/ISAA)
- Approved Terminal Leave ending on Retirement Date (last day of the month)

### **Submission Process**

Submit all required documents to the Transition Center office. Ensure your terminal leave end date matches your retirement date. The Transition Center will use this information to generate your separation orders and DD214 Worksheet.



# Step 4: Survivor Benefit Plan (SBP) Decision

The Survivor Benefit Plan is a crucial aspect of your retirement planning. It provides financial protection for your beneficiaries after your passing. Carefully consider your options and make an informed decision.

#### **Gather Information**

You'll need details about your service history, rank, and years of service to use the calculator effectively.



#### **Estimate Benefits**

The calculator will provide an estimate of your monthly retirement pay based on the information you provide.

Remember that this is an estimate. Your actual retirement pay may vary based on factors such as cost-of-living adjustments and changes in military pay scales.

- Double-check all submitted paperwork for accuracy and completeness
- Stay in regular contact with your S1 office and the Transition Center for updates
- Attend any offered pre-retirement briefings or workshops
- Begin planning for post-retirement life, including employment, education, or volunteer opportunities
- Consider scheduling a final medical and dental check-up before leaving active duty
- Ensure all personal affairs, including housing and relocation plans, are in order
