MEMORANDUM FOR US Army Fort Belvoir Personnel

SUBJECT: Fort Belvoir Policy Memorandum #6, Equal Opportunity Complaint Processing Procedures

1. REFERENCE. Army Regulation 600-20 (Army Command Policy), 24 July 2020.
2. PURPOSE. To establish policy and guidance to all Fort Belvoir personnel on Equal Opportunity (EO) Complaint Procedures.
3. APPLICABILITY. This policy applies to all Fort Belvoir military personnel and anyone seeking EO services under the Garrison GCMCA.
4. POLICY. Soldiers and their Family members have the right to file complaints of discrimination and/or reprisal if they believe they have been discriminated against either on or off post because of race, color, religion, sex (gender identity), national origin, or sexual orientation.
5. PROCEDURES.
 - a. Individuals will attempt to resolve complaints informally by speaking to the offender and providing the chain of command an opportunity to resolve the issue. Although using the chain of command is strongly encouraged, it will not serve as the only channel available to the complainant. Alternate channels are listed in AR 600-20 for Soldiers.
 - b. Civilians should refer to AR 690-600 for processing procedures or contact the Equal Employment Opportunity (EEO) Office at 703-805-2006.
 - c. If a complaint cannot be resolved informally, a formal complaint will be documented on DA Form 7279-R and must be reported to the EO office within 72 hours and processed IAW AR 600-20. Any commissioned officer is authorized to administer the oath for EO complaints. If the complaint is against the commander or members of the Chain of Command, it will be directed to a higher echelon commander in the individual's chain or the Installation Equal Opportunity Office.
 - d. Department of the Army personnel are prohibited from taking acts of reprisal against any Soldier for filing a complaint of unlawful discrimination or sexual harassment
