

The Mass Transportation Benefit Program is offered to eligible employees and military service members, to the extent possible, to reduce traffic congestion, preserve the environment, and expand transportation alternatives.

Under this program, participating employees in the National Capital Region (NCR) receive "transit passes" in amount equal to their monthly parking costs (parking costs not included). To receive this benefit, employees must relinquish any federally subsidized parking purposes of qualifying for a parking pass.

Junior Reserve Officers Training Course (JROTC)

Cyber Training and Education Roadmap

- ✓ Concept by the Secretary of the Army for 20 Army JROTC programs in the United States
- ✓ Proposed start date in FY22
- ✓ JROTC students in High School (HS) grades 9 through 12
- ✓ Program will operate alongside an existing JROTC program
- ✓ Focus would be on Cyber Security, Computer Science, & Information Technology for HS students
- ✓ Concept is getting students trained & certified when they graduate HS
- ✓ Possible a joint funded program between HS & Department of the Army
- ✓ JROTC students do not have to obligate to the Army in HS
- ✓ Program Manager has yet to be assigned
- ✓ This new program does not replace the traditional HS JROTC programs
- ✓ New honors and AP level cybersecurity curriculum created by national level experts to earn certifications and transferable credit to college/university

FHWA is working in the area to finalize the design






Walker Gate – Route 235 Intersection Improvement





Access Control Reminders

All visitors 16 years of age and older must have a Fort Belvoir Access Pass to enter the installation. A background check will be conducted to determine your eligibility to access.

Use the Fort Belvoir Web Site

To receive expedited visitor pass please complete one of the two application forms listed below. This will allow you to receive your pass without having to go into the Visitor Center. Visitors who decide to process through the Visitor Center will expect longer waiting times due to COVID-19 procedures. Wait times can exceed 30 minutes.

There are two types of passes available; Un-sponsored and Sponsored.

Un-sponsored passes are for 90 days and can be renewed. This pass is valid through Tulley or Lieber Gate.

Sponsored passes are valid up to one year and can be renewed. This pass is valid through all gates. To receive a sponsored pass you must be sponsored by someone that works or lives on Fort Belvoir. The sponsor must be DoD Civilian or Active Duty U.S. Military. If living on the installation the sponsor must be Active Duty Military or Dependent 18 yrs. of age and older. (all contractors, to include CAC card with the green strip cannot be a sponsor). The application forms must be fully completed and must be legible. Forms that are illegible or not fully complete cannot be processed. Please note, only visitors that input a state-issued driver's license or issued identification card information on the application can apply for the expedited service.

What if I do not want to email it? You can complete the form, print it off, and process through the Visitor Center. Please note, wait time will increase due to COVID-19 procedures. Emailing the form will expedite in receiving a pass.





Access Control Reminders

Once your completed form is emailed and received by the Visitor Center you will receive an automatic email reply. You can then pick up your pass in 72 business hours. You will need to enter Tulley Gate, drive through the commercial/truck lane, and inform the security guard you are picking up your expedited pass. You will need to present your ID, and may be required to present a secondary ID. Please click on **Real ID Act**, which explains why a secondary ID is needed. If you do not have a secondary ID you will not receive a pass.

Please click on **Fitness Determination**. If you have any of these offenses on your criminal record you will not be allowed access.

DAAF- to access this area without an escort you must complete the sponsored form. The sponsor must work on DAAF and be DoD Civilian or Active Duty U.S. Military.

I do not have a state-issued driver's license or identification card? You can complete the form, print it off, and process through the Visitor Center. This will save you time from having to complete the form in the office.

Taxi, Ubers, Lyfts, etc.: Visitors driving these types of vehicles cannot apply for a pass. They will need to drive through the commercial lane at all times.

Foreign Visitors- Foreign visitors that are accessing post for official business must be cleared through the Fort Belvoir DPTMS Security Office. Once cleared they will send you a memorandum, which is considered your access pass. Foreign Visitors accessing not accessing for business must process through the Visitor Center. Please note, foreign visitors must have a valid Homeland Security stamp in their passport. If there is no valid stamp they will need to provide documents stating they are legally here in the United States.
