SUBJECT: Off-Limits Establishments Policy and Order

1. REFERENCE:

- a. AR 190-24, Armed Forces Disciplinary Control Board (AFDCB) and Off-Installation Liaison and Operations, 27 July 2006.
- b. MCoE Supplement 1 to AR 190-24, Armed Forces Disciplinary Control Boards and Off-Installations Military Enforcement Services, July 2015.
- 2. PURPOSE: To establish local policy on areas declared off-limits through the Armed Forces Disciplinary Control Board (AFDCB) process and to order military personnel to comply with the policy.
- 3. POLICY: The following addresses and/or establishments in Columbus, Georgia, and surrounding area have been placed off-limits to all military personnel within the Fort Moore area, to include: Fort Moore, Georgia; Warner Robins Air Logistics Force Base, Warner Robins, GA; the U.S. Naval Reserve Center, Columbus, Georgia; and the Marine Corps Logistics Base, Albany, Georgia, by the AFDCB:

a. Off-Limits Locations:

- (1) 13th Street Bridge, waters and banks of the Chattahoochee River for a distance of 1-mile above and below the 13th Street Bridge between Columbus, Georgia, and Phenix City, Alabama, are designated off-limits for recreational activities, including fishing, wading, and swimming. This does not prevent use of the Riverwalk or adjoining streets and sidewalks but expressly prohibits fishing, wading, and swimming in the river, or walking on rocks in the river or along the river's banks. Commercial whitewater activities surrounding the 13th Street bridge may be utilized provided it's a guided trip conducted by an approved and licensed outfitter or guide. Military personnel are required to wear approved life preservers or flotation devices during all whitewater activities. Viewing of the whitewater course is also permissible from "Wave Island" and the bridge. Military personnel may continue to fish in this area from powerboats, provided the individuals wear approved life preservers or floatation devices.
- (2) Army Concierge, 3201 1st Ave, Columbus, GA 31904; non-vetted transportation and lodging services associated with Mr. John Melton.

- (3) Carousel Lounge, 3003 Victory Dr., Columbus, GA 31903
- (4) Foxy Lady, 3023 Victory Dr., Columbus, GA 31903
- (5) Combat Footgear INC, 2039 Torch Hill Rd, Suite 104, Columbus, GA 31905. On Post activities by Combat Footgear at Ft. Moore, GA including delivery, sales, and product presentation are prohibited. Off post there are no restrictions regarding Combat Footgear Inc. business locations at 2039 Torch Hill Road, Suite 104 and 6783 Veterans Pkwy, Suite 400, Columbus, GA. Service members may utilize online and off post Combat Footgear Inc. business operations.
 - (6) The Skybar, 136 W Magnolia Ave, Auburn, AL 36830
- (7) DoorDash Inc., 901 Market St., San Francisco, CA 94103. Including DoorDash delivery personnel from delivering from off post establishments to on post locations. This does not include AAFES contracted DoorDash delivery personnel who deliver from on post establishments to on post locations and that have been properly vetted by physical security.
- (8) The area along the Chattahoochee River that is located adjacent to Lawson Army Airfield off 82nd Airborne Division Rd, and is commonly known as Engineer Landing, is off limits during nighttime hours to all personnel not conducting training coordinated through Range Operations. The prohibited period begins at sunset and ends at sunrise.
- (9) China Inn Express, 4393 Victory Dr., Columbus, GA 31903. Including delivery personnel from delivering food to on post locations.
 - (10) In the Zone, 2044 Fort Benning Rd, Columbus, GA 31903.
 - (11) Happy Faces, 2046 Fort Benning Rd, Columbus, GA 31903.
- (12) Upatoi Beach area, Fort Moore, GA 31905 located adjacent Upatoi Creek and Engineer Road. This location is deemed to be unsafe for swimming and swimming is prohibited at all times.
- (13) Area of King's Pond Dam, Fort Moore, GA 31905. Posted off-limits by Garrison Commander.
 - (14) Stone Martin Builders, 13 N 8th St, Opelika, AL 36801.
- (15) Window Depot of Chattahoochee Valley, 5471 Miller Court, Columbus, GA 31909.
 - (16) Motel 6, 3050 Victory Drive, Columbus, GA 31903

- b. Punitive Provisions. All military personnel subject to the UCMJ, to include Reservists on active duty for training and National Guard Soldiers in a Title 10 status, are hereby ordered not to visit the listed establishments. This is a lawful general order, violations of which may be punishable under Article 92, UCMJ. This restriction does not apply to law enforcement and other officials acting in their official capacities for a law enforcement or AFDCB purpose IAW AR 190-24.
- c. Publication. Commanders at all levels are responsible for ensuring that this policy is publicized and effectively communicated to all military personnel within their commands. This policy will be conspicuously displayed with other similar policies, and newly assigned Soldiers, including those at Fort Moore for temporary duty, will be briefed on its provisions.
- d. Reporting. This policy does not withdraw UCMJ authority from commanders at any level. However, commanders are directed to copy furnish the Office of the Staff Judge Advocate, Criminal Law Division (ATZB-JAM) with DA Form 4833, Commander's Report of Disciplinary or Administrative Action, when an incident arises under its provisions.
- 4. SUPERSESSION: This policy memorandum supersedes MCoE Policy Memorandum 190-24-10, 13 June 2023, same subject.
- 5. PROPONENT: Directorate of Emergency Services, Law Enforcement Operations, (270) 545-7107. The Staff Judge Advocate, Administrative Law Division, will provide legal review to any proposed changes.
