SUBJECT: Command Policy #8, Joint Service Off-Limits Establishments

1. In accordance with Army Regulation (AR) 190-24, Armed Forces Disciplinary Control Boards and Off-Installation Liaison and Operations, 27 July 2006, and the Memorandum of Understanding Between White Sands Missile Range, Holloman Air Force Base and Headquarters, 1st Armored Division and Fort Bliss, Fort Bliss, Texas, for Armed Forces Disciplinary Control Board, signed 1 March 2016, the Commanding General, Headquarters, 1st Armored Division and Fort Bliss, prohibits service members of Fort Bliss, White Sands Missile Range, and Holloman Air Force Base from patronizing the following establishments

- d. Rockin' Cigar Bar and Grill, 226 Cincinnati Ave., El Paso, TX 79902 (detrimental to welfare of service members).
- e. Cool Arrows, 800 North Zaragoza Road, Suite S, El Paso, TX 79907 (detrimental to welfare of service members).
- f. Herb N Legends, 1920 Zaragoza Road, Suite 104, El Paso, TX 79925 (detrimental to welfare of service members).
- g. Best food Mart, 6200 Dyer Street, El Paso, TX 79904 (detrimental to welfare of service members).
- h. Bo-De-Gas Graff Head Shop, 1791 Zaragoza, Suite C, El Paso, TX 79936 (detrimental to welfare of service members).

SUBJECT: Command Policy #8, Joint Service Off-Limits Establishments

2. Service members from Fort Bliss, White Sands Missile Range, and Holloman Air Force Base are ordered not to enter or patronize these off-limits establishments or their locations. Violations of this order are punishable under Article 92, Uniform Code of Military Justice.
3. Units will place this memorandum on their unit bulletin boards and give it the widest dissemination.
4. This memorandum supersedes all previous 1st Armored Division and Fort Bliss, White Sands Missile Range, and Holloman Air Force Base Off-Limits Lists.
