MEMORANDUM FOR RECORD

SUBJECT: Commanding General Policy #12- Suicide Response Team and Suspected Suicide Fatality Review and Analysis Board Policy

1. **References.**

- a. Department of the Army (DA) Pamphlet (PAM) 600-24, Health Promotion, Risk Reduction, and Suicide Prevention, 14 April 2015.

2. **Purpose.** In accordance with AR 600-92, this policy establishes Fort Bliss Suicide Response Team (SRT) and Suspected Suicide Fatality Review and Analysis Board (S2FRAB) policy for all units under my Senior Mission Command authority.

3. **Applicability.** This policy applies to all Soldiers, DoD Service members, DA Civilians, and their families assigned to Fort Bliss, TX.

4. **Policy.**

a. **Suicide Response Team (SRT).** In accordance with AR 600-92 and ALARACT 088/2023, this memorandum establishes installation policy for the SRT after a suicide or suspected suicide.

(1) An SRT will convene, chaired by the Division Chief of Staff, the affected unit, and other personnel within 48 hours of the event of a suicide or suspected suicide to gather information and marshal resources for the affected unit.

(2) All SRT members will sign a non-disclosure agreement prior to attendance of their first SRT to ensure protection of privacy and sensitive personal data.

(3) In cases where AR 600-92 required personnel specified in paragraph 3-5 are unavailable to attend the SRT due to operational requirements, the following personnel are authorized in lieu of:

b. **Suspected Suicide Fatality Review and Analysis Boards (S2FRAB).** IAW AR 600-92 paragraph 3-6, Fort Bliss will convene a S2FRAB NLT 60 days after a completed or suspected suicide. The S2FRAB will conduct a comprehensive, objective, standardized, and holistic analysis of the individual and environmental factors that may have contributed to, or enabled the completed suicide. Currently, the standing Fort Bliss Fatality review board currently fulfills this requirement of paragraph 3-6.
