SUBJECT: Suicide Prevention

- 2. Suicide is a singular, tragic and preventable event that adversely impacts the very core of our Families, friends, and our units. It is all of our responsibility to be committed to fostering an environment of trust and being approachable.
- 3. It is paramount that we are educated on the signs, symptoms and possess the necessary skillsets in order to initiate preventative measures.
- 4. The Ask, Care and Escort model is an effective measure in identifying and preventing a potential Suicide:
- a. **A**: Ask the question; there is only one way. Are you going to/thinking about killing yourself?
- b. **C**: Care for the individual with compassion as if they were your immediate family or how you would want someone to treat a member of your Family in this situation.
  - c. **E**: Escort the individual immediately to a safe spot and never leave them unattended.

- 5. I implore each of you to become actively engaged in preventing suicide. Our collective actions will only serve to strengthen our resolve for the Garrison team and Family.
- 6. Suicide prevention is a command program. Leaders will conduct Suicide Prevention and Awareness face to face classes, annually, in order to increase awareness of suicide risk factors and warning signs. It will also serve to sharpen our intervention skills to respond promptly, effectively and deal with at-risk individuals.
