"Login in with CAC. Click "DD 2795" tab. Click "Start new survey" button. You do NOT need to print out the document, it will be electronically sent to medical provider. Status must be "member portion complete." Awaiting the SRPC Providers completion.</p>

Information Security: Within 60 days of CRC Report date.

Log into <https://learn.atis.army.mil/> with your DOD CAC or Username Password. Click on the "Course Catalog". "Select Mandatory Courses". Enter **Information Security** in the search box. Click register. Click the "Launch" button.

7 **Contractors only:** Go to <https://www.cdse.edu/Training/eLearning/IF011/>, Course Number IF0F11.16 (**Introduction to Information Security**). Set up a username and password and all required information. Once completed, print out the certificate, the website does not save certificates. The site is accessible from mobile devices.
