#### **Comments submitted 01 September**

- Comment 1: Gate 1 entry-people try to merge to left lane immediately after turning, blocking the intersection every day! Putting small barriers between the two lanes would encourage people to keep moving out of the intersection and then they can merge closer to the gate.
- ✓ DES Response: Placing barriers in the intersection or to separate lanes would be more harmful and would cause more of a traffic problem. DES/Law Enforcement section has spoken with Clarksville PD to monitor the intersection at gate one to help detour these undisciplined drivers. DES continues to ask all drivers to drive defensively during hours of high traffic.

- Comment 2: I am seeing a lot of electric cars on post. Can we get a charging station on post? Maybe in PX parking in the back where it is usually empty.
