MEMORANDUM FOR SEE DISTRIBUTION

SUBJECT: General Order: Fort Campbell COVID-19 Response: Maintaining Good Order and Discipline Measures

1. **Purpose.** To codify and update prudent measures that will continue positive health protection trends for the Fort Campbell community, reduce the potential for transmission or retransmission of COVID-19, and prepare Fort Campbell for a balanced return to essential readiness and training activities. Prudent measures for social distancing will continue the positive progress that Fort Campbell has made to slow the spread of COVID-19. A disciplined and balanced approach to mission essential manning protocols, smart social distancing, and continued limitations on unnecessary travel will protect Fort Campbell and our local communities in our fight against COVID-19. As the local and state authorities begin balanced approaches to reopening for business, Fort Campbell will remain postured to protect our community from the rapidly evolving COVID-19 outbreak.

2. **Applicability and Punitive Nature.** This order applies to all Service Members (SMs) assigned, attached, TDY, or present on Fort Campbell. Paragraphs 2 and 3 of this order are punitive subjecting those who violate them to potential adverse administrative action or action under the Uniform Code of Military Justice (UCMJ). Family members and members of our civilian workforce are encouraged to adhere to health protection measures. Failure to safeguard our community and Soldiers may result in a ban from the installation.

2. **Travel and Off-Post Restrictions.**

a. Service members are still restricted from travel outside of the local travel area. The local area is 50 miles from Fort Campbell. SMs may travel directly to and from the Nashville Airport, or Nashville area medical facilities. Nonessential stops will not be made outside of the 50 mile restriction during those trips. Service Members who live outside of the 50 mile restriction will adhere to limitations placed on all local travel as discussed below.

b. Local travel remains limited to Fort Campbell and to life support activities in the vicinity of your residence. This includes travel related to child care, medical appointments, obtaining goods at grocery stores, food delivery outlets, pick-up and delivery services, beverage stores, pharmacies, banks, refueling stations, outdoor physical activities while

maintaining social distance from others and adhering to evolving local and state civilian orders, or as directed and approved by military authorities.

c. For Soldiers, family members, and members of the civilian workforce who are granted exceptions to policy (ETPs) based on updated guidance for travel restrictions, the first O-6 in the chain of command will ensure prudent health measures, including quarantine when appropriate, are applied for travel to or from Fort Campbell.

3. Social Distancing.

a. No more than a total of three (3) persons are allowed in a barracks room. Barracks room is defined as all barracks rooms, common areas, and latrines within a barrack unit.

b. Appropriate social distancing will be maintained, though commanders may make exceptions for mission essential activities, such as maintenance activities. Use of masks in accordance with DoD and Army guidance is required when social distancing cannot be maintained.

c. Prohibitions from participating in social and recreational activities that include more than ten (10) persons, not to include family members, in close contact remain in place. Close contact is defined as six feet or less, or as further refined by me based upon changing conditions related to COVID-19. This includes, but is not limited to, neighborhood/ barracks parties, outdoor BBQs, and athletic activities other than individual sports or recreation activities that can be conducted with health protection measures.

d. Entry into quarantine or isolation facilities by personnel other than those ordered into quarantine or isolation or assigned by the chain of command to perform duties at the facility is prohibited.

4. Standards of Conduct for Minimal Staffing.

a. The duty day for all personnel not in a leave status is Monday through Friday between 0630 and 1700, or as otherwise directed by the chain of command. Commanders are encouraged to consider shift work to support maintenance priorities while balancing health protection protocols.

b. Social distancing is required for all activities, whenever possible. Units should not hold formations. Accountability shall be maintained by other means.

c. Leader's Checks. Leader engagement remains the most critical tool in the fight against COVID-19. Leaders are expected to conduct routine checks on the health, safety, and well-being of their Soldiers, including those teleworking.

d. Army policy and regulations prohibiting the consumption of alcohol during the duty day apply to all personnel (See paragraph 4a).

Enclosure to General Order: Fort Campbell COVID-19 Response: Maintaining Good Order and Discipline Measures

1. Coordinating Instructions. Unit commanders and supervisors are required to ensure personnel are briefed on the contents of this General Order. Unless prohibited by U.S. law, DoD regulation, or a higher commander's policy, commanders, who are Special Court-Martial Convening Authorities, may further restrict their personnel as they deem necessary.

2. Terms.

a. Teleworking is the performance of duties and responsibilities of a SM's position and other authorized activities, from the SM's residence or other authorized location.

b. Social distancing includes the practice of maintaining six (6) feet spacing between all personnel indoors and outdoors.

c. The local travel area is defined as the 50 mile radius surrounding Fort Campbell, Kentucky to include the Nashville Airport, or Nashville area medical facilities.

d. Life Support Activities are those activities that directly support the health and welfare of SMs and their dependents. Examples include, medical appointments, purchase of food, purchase of hygiene and cleaning supplies, refueling and maintaining vehicles, grocery shopping, and essential postal, banking, and laundry services.
