YOU MAY QUALIFY FOR A ~~NON~~ RESIDENT TAX EXEMPTION

1

- You are an active duty military member assigned to a duty station in Colorado, OR

2

- You are assigned to a unit in Colorado from which you were then assigned to an unaccompanied / remote duty station.

NOTE: The tax exemption is only valid for OWNERSHIP TAXES in Colorado.



WHAT IS NEEDED FOR LOWER REGISTRATION FEES

1

- A copy of your orders stationing you at a military facility in Colorado is required.
- A military ID is required.

2

- An end-of-month Leave and Earning Statement (LES) within the last three months is required. It must show a tax withholding state other than Colorado.

WHAT IS OWNERSHIP TAX?

This fee is a personal property tax. This tax is based on the year of the vehicle, original taxable value and date of purchase (on newly acquired vehicles) or previous expiration date of the license plates (on expired renewals).

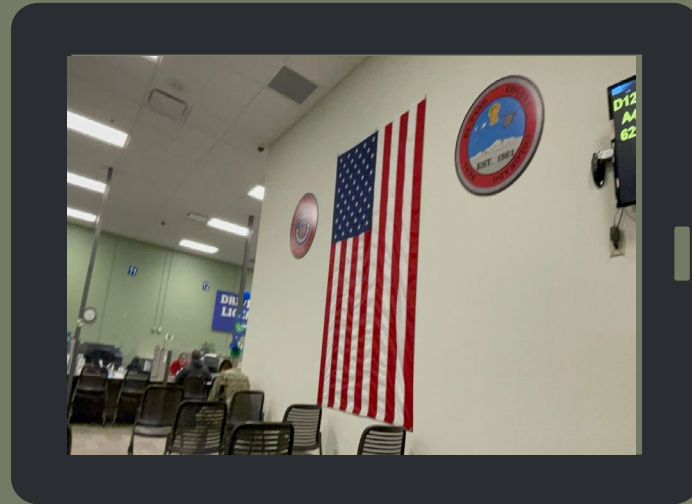
