Fort Cavazos Access and Visitor Passes

All vistors to Fort Cavazos must have a valid military
ID Card or a visitor's pass from the
Marvin Leath Visitors Welcome Center.

The Visitors Welcome Center is located off of Interstate 14 on T.J. Mills Blvd, Building 69012, adjacent to the Fort Cavazos Main Gate. The Visitors Welcome Center will provide visitor access passes for non-DoD ID Card Holders. All non-DoD visitors entering the Fort Cavazos Installation must have Real ID compliant forms of identification and/or a valid passport from their country of residence showing valid entry into the United States. Concealed and Open Carry Illegal on Fort Cavazos

Fort Cavazos is a federal installation. Neither Conceal nor Open Carry are allowed. All weapons on the installation MUST BE registered. No exceptions. For more information, call (254) 288-1170.

National Mounted Warrior Museum (NMWM) to Open Soon

The National Mounted Warrior Museum (NMWM) is tentatively scheduled to open on 18 September 2024. The museum will honor our mounted Soldiers and will feature the story line of America's warfighting from the Revolutionary War to the conflicts of today. The 1st Cavalry Division and 3d Cavalry Regiment Museums are closed. The exhibits contained in those museums were transferred to the NMWM. The NMWM is located near the Marvin Leath Visitors Welcome Center and the 1st Cavalry Division Stables.

Blue Retirement ID Card is Being Phased Out

Effective January 2026, the Blue Retirement ID Card will not be accepted for entry to any military installation. Do not wait until the last day to get your new USID Card. Schedule your ID Card Facility appointment now. See "How To" on page 4.

Age for Permanent USID Card

Upon reaching the age of 65, retired members will receive a permanent (indefinite) USID Card. Spouses will not receive their permanent USID Card until they reach the age of 75. The Retiree and spouse must have applied for their Medicare Part A and B and be in receipt of their Medicare Card from the Social Security Administration. Please see detailed information on page 3.

USID Cards - Remote Issue

Remotely issued ID Cards are now valid for their full life-cycle (indefinite cards are indefinite; and dependent ID Cards are valid for 4 years, unless eligibility ends sooner.) The remote process requires you to mail or email all required documents to the ID Card Facility. You will only receive notification if your documents are not in order or when it's time to pick up your card, normally 4-5 business days after your documents are received. The Remote Process is not recommended for special cases or complex situations.

Legal Assistance

The Fort Cavazos Legal Assistance Office will be open for Retiree Apprecation Days from 0900-1600 on Friday, 25 October 2024 and 1000-1400 on Saturday, 26 October 2024. Services will include drafting and execution of Wills, Advance Medical Directives, and Powers of Attorney (POAs).

If you are in need of a Will, it is highly recommended that you complete a Will Questionnaire prior to meeting with an Attorney. Questionnaires are provided on pages 10 & 11 or are available by email, please contact usarmy.cavazos.iii-corps.mbx.sja-legal-asst@army.mil, or you can request one by sending us an email through our Facebook page at:

Please note that there are some services that are outside the scope of the Army Legal Assistance Program. In those cases, we may need to refer you to a private civilian attorney or other agency from which assistance may be obtained.

Each person who is seeking legal assistance must present a valid military identification card as proof of eligibility for these services.

USID Card Facility Update

location >>>

The Fort Cavazos ID Card Facility will be open for walkins on 26 October, 2024 from 1000-1400 for Retirees and their Family members.

The Fort Cavazos ID Card Facility is located in Building 130 on the corner of Legends Way (formerly Battalion Ave) and T.J. Mills Boulevard.

hours of operations >>>

The Fort Cavazos ID Card Facility is open daily M-F from 0800-1130 and 1300-1530 by appointment only. Walk-ins are highly discouraged. The facility is closed weekends and federal holidays.

appointments >>>

Information on how to make an appointment is provided in the "how to" section of the newsletter. The ID Card Appointment Scheduler is an application provided by the Defense Military Data Center (DMDC). The Fort Cavazos ID Card Facility does not control its availability or speed.

What to Bring to Your ID Card Appointment

- -Two (2) forms of valid state or federal identification are required for all adults (18 yrs or older), one must be a photo ID. Identification documents may include a military ID Card, drivers license or passport. Children 10 years and older require one (1) form of identification which can include a Social Security Card, Birth Certificate or dependent ID Card.
- -Sponsor must be present for all transactions or Family Member must have current verified DD Form 1172-2 (APPLICATION FOR ID Cards/DEERS Enrollment) or valid General or Special Power of Attorney. Special Power of Attorney must state ID Cards/DEERS enrollments.
- -All documents must be original. Ensure all names (First and Last) on the identification provided match the names in DEERS.

For special cases, please call and confirm required documentation at (254) 287-5670 or visit the Fort Cavazos website at http://home.army.mil/cavazos and go to quick links, click on ID Cards.

MEDICARE Enrollment and TRICARE for Life

The window for enrollment for MEDICARE spans seven months (3 months prior to birth month, birth month at age 65, and 3 months following). If you do not enroll at age 65, there is a penalty, and you lose TRICARE coverage until you eventually enroll in MEDICARE. Although the MEDICARE window spans several months, BE ADVISED, if you are approaching age 65, check the expiration date of your ID card; it should expire on the last day of the month preceding your birth month. At that time your medical benefits under regular TRICARE will also expire.

Enrollment in MEDICARE PARTS A and B, and possession of your MEDICARE card is required for update in DEERS and issuance of a new ID card which enrolls you in TRICARE FOR LIFE. Retirees and spouses must apply for their Medicare Card at least 90 days prior to their 65th birth date through the Social Security Administration.

To enroll in MEDICARE parts A and B, contact the Social Security Administration at (800) 772-1213 (online at www.ssa.gov) or MEDICARE at 800-633-4227 (online at www.medicare.gov). If you are deaf or hard of hearing, you may call the Social Security TTY number (800) 325-0778. You can also visit your local Social Security office. If you apply online, once approved, you can print your own MEDICARE card. If you are enrolled in MEDICARE when you are first eligible, but do not yet receive Social Security, MEDICARE will bill you for your MEDICARE P art B premiums. You can also call a Fort Cavazos ID Card Representative if you have questions at (254) 287-5670.

Schedule an ID Card Appointment

- -Go to the online scheduler located at https://idco.dmdc.osd/mil/idco or the Fort Cavazos Website: Under "Quick Links" select "ID Cards and DEERS"; scroll down to "Appointments" and select "Click here to Schedule an Appointment."
- -Select: "ID Card Office Locator & Appointments"
- -Enter "Fort Cavazos"; Select Location #2 "Fort Cavazos" (Bldg 130 Only Dep/Retirees/DAV (NO CAC)
- -After you select Location #2, select "Schedule Appointment."
- -Available appointments will be visible in the calendar on your screen. Select an available date (by scrolling up or down) and then chose an open appointment time that fits your schedule, select "Book This Appointment." Ensure that you read "Important Site Information" then select "Continue."
- -Once you have added your information, select "Save" and you will receive a confirmation of your appointment to include date and time.

Report the Death of a Retired Service Member

- 1. Visit the DFAS Homepage, https://www.dfas.mil
 - a. Select the "Retired Military & Annuitants Banner"
 - b. Next, select "Click Here to Report the Death of a Retiree"
 - c. Select "Agree"
 - d. Complete and Submit the Form on-line
- 2. Contact the Casualty Assistance Center (CAC) anytime by calling (254) 287-3395. The CAC will report the death to the Defense Finance and Accounting Service to stop retired pay and initiate the Survivor Benefits process. This is applicable to Army Reservist and Army National Guard members who are in a pay status at time of death.

Update Your Address or Other Retired Pay File Information

When to update your account:

It is recommended that you review your retired pay account at least once a year to make sure your record is up to date. Also look at your allotments every so often, you might find that you want to make a change.

- -If you've switched Banks or Opened a New Account. Your banking information is perhaps the most important thing to keep updated. Please ensure that your payments are going to your new account before you close out your old account.
- -If you Move to a New Home or Relocate Temporarily. You need to update your mailing address whenever it changes. DFAS is always sending important information you don't want to miss.
- -If You've Married, Divorced or Added to Your Family. First update your Arrears Pay Beneficiary, the person who receives your final payment when you die and you might also need to update your SBP beneficiary.
