MEMORANDUM FOR ALL PERSONNEL ASSIGNED TO UNITED STATES ARMY
GARRISON (USAG) DAEGU AND AREA IV

SUBJECT: United States Army Garrison (USAG) Daegu Policy Letter #21-43, Use of
Traffic Control Points and Road Guards

1. REFERENCES:

- a. USFK Regulation 190-1, Motor Vehicle Traffic Supervision, dated 18 February 2021
- b. AR 190-5, Motor Vehicle Traffic Supervision, dated 22 May 2006
- c. AR 385-10, The Army Safety Program, dated 24 February 2017

2. PURPOSE: This policy establishes the guidance on establishment of Traffic Control Points (TCP) and use of road guards to assure safe and efficient movement of traffic on the installations in Area IV.

3. APPLICABILITY: This policy applies to all Military Members, DoD Civilian, Family Members and Contractors, assigned to or under the operational control of USAG Daegu and Area IV.

4. The establishment of traffic control points on any installation in Area IV that obstruct the free flow of traffic for routine vehicles due to ceremonies of any kind without approval of the Daegu Garrison Commander or their designated representative is prohibited.

5. Parking details and road guards may still provide directions to incoming special event personnel and VIPs to Area IV installations, but are not authorized to stop traffic to assist special events or VIP vehicles in movement.

6. Road guards are authorized to direct traffic only for Soldier's movement in formations. However, all efforts will be made to utilize the available sidewalks to maximum utility. The road guards will utilize flashlights (during limited visibility) and reflective vests when controlling traffic. At no time will any member of the formation cross over the centerline of the roadway to exceed more than one half of the roadway. This is to allow for safe flow of traffic around the formations.

7. The only personnel authorized to establish TCPs and/or close routes are personnel from the Directorate of Emergency Services (DES) for emergencies and Department of Public Works (DPW) for road construction.
