MEMORANDUM FOR ALL PERSONNEL ASSIGNED TO UNITED STATES ARMY  
GARRISON (USAG) DAEGU AND AREA IV INSTALLATIONS

SUBJECT: United States Army Garrison (USAG) Daegu Policy Letter # 21-65, Risk  
Reduction Program (RRP) Operations Policy

1. References:

2. The proponent of this policy is the Army Substance Abuse Program Manager.

3. This policy is effective immediately. It remains in effect until rescinded or superseded.

4. Purposes: This memorandum describes the AREA IV, USAG Daegu Risk Reduction Program (RRP).

5. Policy:

a. The RRP is a commander's tool designed to identify and reduce Soldiers' high-risk behaviors. High risk behaviors are behaviors that place the individual or others in danger or harms' way. For example areas of substance abuse, suicide, and crimes against property. RRP focus on affective use of installation resources and a coordinated effort between commanders and installation agencies to implement intervention and prevention strategy.

b. Command teams (sitting and future) will request a Commanders' Risk Reduction Toolkit (CRRT) account through <https://vantage.army.mil>, and follow the Army Vantage CRRT Command Teams Account Instructions. Command Teams are defined as current or projected BN Commanders, BN CSMs, Company Commanders, and Company 1SGs assuming responsibility **within 30 days**.

c. The Risk Reduction Prevention Coordinator (RRPC) or the ASAP Specialist will administer the Unit Risk Inventory (URI) to units assigned to Area IV, USAG Daegu and recommend prevention/intervention strategies to leaders based on survey results and overall risk factors. The URI should be administered no more than once every 12 months to the same unit because of "test familiarity" or "test burnout" and because there are questions about the Soldier's behavior within the past 12 months.

d. Once high-risk behaviors are identified, intervention through community service programs will begin, to include: FAP, Safety Office, Alcohol & drug prevention education, Behavioral Health/Chaplains, CID, Provost Marshall, Financial Readiness, and Public Health will coordinate with the RRPC to provide class trainings on identified high-risk areas of concern to mitigate behaviors. Commanders and subject matter experts can quickly identify problem areas and then react by implementing intervention measures.

e. Risk data is provided to commanders furnishing a "snap shot" of their unit's as it relates to high-risk behaviors (deaths/suicides, accidents, suicide attempts/ideations, AWOLs, drug offenses, traffic violations, crimes against persons, crimes against, crimes against society, crimes against property, domestic violence, child abuse and neglect, alcohol offenses, crimes against-persons, property and society, and positive UA's). The Installation Prevention Team (IPT), under the direction of the Garrison Commander, acts as a working group for targeting high-risk behaviors in the active duty population at USAG Daegu, Area IV.

f. The IPT meets quarterly and reviews statistics to analyze high risk data, identify trends, monitors outcomes, develops prevention strategies and make recommendations for interventions which are addressed at the quarterly FY Commander's Ready and Resiliency Council (CR2C).
