MEMORANDUM FOR ALL MILITARY PERSONNEL, CIVILIAN EMPLOYEES, DEPENDENTS, AND VISITORS TO UNITED STATES ARMY GARRISON DAEGU INSTALLATIONS WITHIN AREA IV

SUBJECT: United States Army Garrison (USAG) Daegu Policy Letter #21-06, Standards of Dress

- 1. References.
 - a. AR 670-1 (Wear and Appearance of Army Uniforms and Insignia), 26 JAN 21.
 - b. AR 30-22 (Army Food Program), 17 JUL 19.
 - c. TB Med 530 (Tri-Service Food Code), 1 MAR 19.
- 2. Purpose. To establish a professional standard of appearance throughout Area IV and to positively represent the United States in the Republic of Korea.
- 3. Applicability. This policy applies to all individuals who work on, reside on, or visit any U.S. Army installations, facilities, or work sites in Area IV.
- 4. Policy. While Soldiers particularly need to present a professional appearance at all times, our Families, retirees, Civilians, and guests in Area IV should also take care to ensure their clothing is respectful of our Host Nation social and cultural mores. We are guests in an overseas location and represent the U.S. Armed Forces. The way we dress reflects on the United States and directly affects the U.S.-ROK alliance.
- a. All military personnel must wear the prescribed uniform of the day while conducting official business in Area IV. Exceptions include emergency situations, personnel in an approved leave status, and Soldiers whose medical profile precludes their ability to wear the prescribed uniform of the day.
- b. Army uniform clothing items authorized for wear with civilian clothes are limited to those listed in AR 670-1, para 3-9.
 - c. Area IV dining facilities:
 - (1) Soldiers in uniform must ensure their uniform is complete, clean, and neat.
 - (2) Military and civilian headgear will be removed.

- (3) Military issue t-shirts, either white or brown in color, will not be worn as outer garments.
- d. Soldiers can wear the APFU on and off duty for fitness training. Soldiers are not authorized to wear an excessively soiled APFU in any installation facility.
 - e. The following clothing is prohibited from being worn on any Area IV installation:
- (1) Clothing that includes obscene, vulgar, slanderous, or sexually suggestive language.
 - (2) Clothing that depicts drug paraphernalia or any illegal activity.
- (3) Clothing with disparaging messages concerning the military or the United States Government.
- 5. Military personnel, Civilians, Family members, and any other individual failing to meet the above prescribed dress standards may be refused admittance to AAFES, MWR, and dining facilities located within Area IV installations. Soldiers should set the example by correcting those who fail to observe these standards.

SUBJECT: Legal Review - USAG Daegu Policy Letter 21-06, Standards of Dress

- 1. References.
 - a. AR 670-1 (Wear and Appearance of Army Uniforms and Insignia), 26 JAN 21.
 - b. AR 30-22 (Army Food Program), 17 JUL 19.
- 2. Legal conclusion. I have no legal objection to the proposed policy pertaining to standards of dress on USAG Daegu installations in Area IV.
- 3. Law and analysis. The proposed policy applies to both military and civilian personnel, as well as dependents. However, the policy is not punitive and rather mandates compliance for access to the installation and installation facilities.
- a. The garrison commander has inherent authority to exclude personnel from the installation and its facilities. See generally Greer v. Spock, 424 U.S. 828 (1976) (holding that military installations are not public forums for civilian political activity; that Commanders have the "historically unquestioned power" to summarily exclude civilians; "There is nothing in the Constitution that disables a military commander from acting to avert what he perceives to be a clear danger to the loyalty, discipline, or morale of troops on the base under his command.").
- b. This policy directly relates to the discipline and morale of troops on USAG Daegu installations. The policy regulates clothing at military dining facilities. It also prohibits clothing with language that is obscene, vulgar, slanderous, sexually suggestive, encourages illegal activity, or disparaging to the United States. Each of these categories of prohibited language directly relate to a lawful, military nexus for regulation
