SUBJECT: United States Army Garrison (USAG) Daegu Command Policy Letter #26-32, Environmental Quality Control Committee (EQCC)

1. Reference: Army Regulation (AR) 200-1, 13 December 2007, Environmental Protection and Enhancement.
2. Purpose: To provide guidelines to conduct Garrison level EQCC. The EQCC assists the USAG Daegu Commander to ensure proper management of environmental protection. The committee advises the Garrison Commander for all aspects of environmental compliance, pollution prevention, and protection of natural and cultural resources.
3. Membership: USAG Daegu EQCC shall be chaired by the Garrison Commander and/or Deputy to the Garrison Commander. The membership will consist of personnel representing the operational, logistics, engineering, planning, resource management, legal, medical, environmental, Family and Morale, Welfare, and Recreation (FMWR), commissary, exchange service, and safety interests of the command, including military installation tenant activities that have potential adverse environmental impacts.
4. EQCC will meet quarterly and discuss environmental actions and activities that have transpired during the previous quarter. Environmental topics will be briefed with a plan to resolve any current issues or systemic problems which were identified from previous quarters. The Garrison Commander may direct topics of discussion for command emphasis.
