Masks / Changes / Updates:

- ❖ All personnel (vaccinated and unvaccinated) will wear a mask in all indoor facilities on Fort Detrick & Forest Glen. Personnel in vehicles with multiple occupants who are not from the same family must also wear masks. Exceptions include: (1) for brief periods of time when eating and drinking while maintaining social distancing; (2) when the mask is required to be lowered briefly for identification or security purposes; (3) when necessary to reasonably accommodate a civilian employee with a disability; (4) if fully vaccinated, personnel can remove masks in single occupancy offices with floor to ceiling walls and doors shut.
- ❖ Fully vaccinated personnel are not required to wear a mask outdoors. All vaccinated SMs must carry and show their CDC COVID-19 Vaccination Record Card (or digital photo) upon request. SMs should consult PCMs if they require a replacement card.
- ❖ Unvaccinated personnel must wear a mask in outdoor workplaces when social distancing is not possible (e.g. - Motorpool, Open Maintenance Bay, and PT formations).
- ❖ Masks are not required in personal living spaces (On post quarters and individual Barracks room).
- ❖ Until further notice, Combatives Training and other similar close contact training is suspended.
- ❖ All indoor dining (IAW limitations stated above), gyms, MWR facilities, worship, and retail facilities are authorized to operate at 100% capacity. However, if indoors, masks must be worn regardless of vaccination status.
- ❖ Masks are required AT ALL times, by all patrons, while inside a gym, regardless of vaccination status. Masks can be removed ONLY while showering or swimming. Saunas are closed until further notice.
- ❖ Indoor ceremonies are authorized 100% capacity -- with masks, regardless of vaccination status.

Isolation/Quarantine Guidance:

- ❖ Close Contact – Unvaccinated Individuals
 - Unvaccinated individuals who have been in close contact with someone who has COVID-19.
 - Stay home for 10 days after the last contact with a person who has COVID-19, Commanders may choose to enforce longer ROM/quarantine IAW DoD/CDC Guidance
 - ❖ Close Contact – Fully Vaccinated Individuals
 - Fully vaccinated individuals who have close contact with a COVID-19 positive individual are not required to stay home.
 - CDC recommends such individuals get tested 3-5 days after the exposure. If test results positive – stay home for 10 days.
 - ❖ Persons with COVID-19 (positive test)
 - Stay Home – regardless of whether symptomatic or asymptomatic, vaccinated or unvaccinated
 - Symptomatic may be able to return after – 10 days since symptoms first appeared AND, 24 hours with no fever without the use of fever reducing medications AND, Other symptoms of COVID-19 are improving (consult healthcare provider if needed).
 - Asymptomatic may return after 10 days since the positive test.
 - Service Members require medical clearance from their PCM prior to return to in-person duty.
- *Close Contact defined as within 6 feet of someone who has COVID-19 for a cumulative total of 15 minutes or more over a 24-hour period.

Detrick Travel Procedures:

- ❖ O6 Commanders and above approve ETPs for travel/leave outside of the United States and its territories.
- ❖ Commanders approve domestic travel (U.S. & its territories) based on State/County COVID risk assessment; counsel accordingly. IAW AR 600-8-10, Commanders may limit leave for unvaccinated Soldiers based on mission/post travel ROM requirements.

- ❖ Vaccinated personnel arriving at Fort Detrick are not required to ROM or test unless symptomatic.

INSTALLATION SAFETY BULLETIN SB 21-09-01

Prevent Serious Eye Injuries...Protect Your Eyes

3 out of 5 injuries – the worker was not wearing eye protection at the time of accident.- *Bureau of Labor Statistics Survey*

When is eye protection needed? - Workplace eye protection is needed when the following potential eye hazards are present:

- **Projectiles** (dust, concrete, metal, wood and other particles).
- **Chemicals** (splashes and fumes).
- **Radiation** (especially visible light, ultraviolet radiation, heat or infrared radiation, and lasers).
- **Bloodborne pathogens** (hepatitis or HIV) from blood and body fluids.

How can I protect my eyes?

- **Nonprescription and prescription safety glasses.**
 - Lenses and frames are much stronger than regular eyeglasses.
 - Must meet standards of the American National Standards Institute (ANSI). Look for the Z87 mark on the lens or frame.
 - Safety glasses provide eye protection for general working conditions where there may be dust, chips or flying particles. Side shields and wraparound-style safety glasses can provide additional side protection.
- **Goggles** - provide protection from impact, dust and chemical splash.
 - Highly impact-resistant.
 - Goggles can be worn over prescription glasses and contact lenses.



- **Face shields and helmets.** Full face shields protect workers exposed to chemicals, heat or blood-borne pathogens. Helmets are used for welding or working with molten materials. They need to be used in conjunction with safety glasses or goggles, so the eyes are protected when the shield is lifted.
- **Special protection.** Helmets or goggles with special filters to protect the eyes from optical radiation exposure should be used for welding or working with lasers.

The ABC's of Safe Sleep

A

Alone in Their Sleeping Space

Alone means removing all items from baby's crib:

- ⊘ Stuffed animals
- ⊘ Loose blankets (swaddling is ok until your baby can roll over)
- ⊘ Crib bumpers
- ⊘ Anything that could increase risk of strangulation

Alone doesn't mean away.

The risk of SIDS reduces by 50% for babies who sleep in the same room as their parent. Share your room with baby for at least their first six months.



Placed on **Back**

B

Always place baby on their back on a firm surface to sleep.

C

Asleep in **Crib**

Use a crib, bassinet, or portable crib that meets safety standards (See <https://www.cpsc.gov/SafeSleep>).

Never let baby sleep on a couch or sofa.

If baby falls asleep in their car seat, move them to their safe sleep spot at your destination.

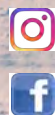
