SUBJECT: Temporary Exception to Policy Memorandum 608-10-1, Child and Youth Supervision Policy

1. References.

a. Memorandum, HQ USAG, IMFD-ZA, 28 Jan 20, subject: Fort Detrick Policy Memorandum 608-10-1, Child and Youth Supervision Policy.

c. Maryland Family Law § 5-801, (Confinement in Dwelling, Building, Enclosure, or Motor Vehicle).

2. This memorandum serves as a temporary exception to policy for reference 1.a., above. Section 6.c.(3) is temporarily modified to remove the language (no more than three continuous hours) to alleviate undue burden of child care during the Coronavirus Diseases (COVID-19) temporary closure of schools through 27 March 2020 (reference 1.b. above). Paragraph 6.c.(3) will follow Maryland Family Law § 5-801:

a. A person who is charged with the care of a child under the age of 8 years may not allow the child to be locked or confined in a dwelling, building, enclosure, or motor vehicle while the person charged is absent and the dwelling, building, enclosure, or motor vehicle is out of the sight of the person charged unless the person charged provides a reliable person at least 13 years old to remain with the child to protect the child.

b. A person who violates this section is guilty of a misdemeanor and on conviction is subject to a fine not exceeding \$500 or imprisonment not exceeding 30 days, or both.

3. This applies to all Service Members, the personnel of Headquarters, U.S. Army Garrison, mission partners, contractors, and Civilians who have assigned responsibilities, live or visit on Fort Detrick, Maryland and the Forest Glen Annex, Silver Spring, Maryland.

4. This exception is valid until 28 March 2020.
