

Team Detroit Arsenal,

Adhering with Army guidance, the Detroit Arsenal will continue to maximize telework flexibilities for the near term. Senior leaders are forecasting based on a combination of HPCON, Army guidance, mission essentiality and State of Michigan executive orders. Please work directly with your chain of command if you need clarity on your organization's position.

If you missed my 9.0 message we changed the installation HPCON Level to Charlie last week, in accordance with the Army EXORD FRAGO 14. This FRAGO neither directs the restriction of access to the installation nor directs us to mission essential staffing. The Arsenal is not "closed." We are at HPCON Charlie due to the increase of COVID in the local community, and the stance we are taking as a team. We ask that you continue doing business as you have been doing business.

Two weeks have passed since many of you went home and set up your telework offices. Thank you for your part in helping us social distance. Having fewer people on post really helps us dial in the risk for those who are still here.

To our teammates still on post - I have an important ask; if you are not feeling well, please contact your supervisor and make arrangements to stay home. This is crucial to helping me keep the infrastructure of the installation mission capable. My request is targeted to protect our emergency services team, our BASEOPS team and custodial workers, and the rest folks who are still onsite, and take care of you - we need to look out for each other and we are counting on you help us retain the health of our collective force.

Thank you for all your efforts, including limiting your off duty interactions in public and deliberate actions to maintain your health. We care about your well-being.
