# SAFETY AND YOUR EFFICIENCY REPORT

Did you know that safety is so important that it is a required topic on your efficiency report counseling form and on your final OER, NCOER and Civilian performance report? Raters and supervisors are you making sure safety is addressed as part of duty performance?

So what should be talked

about and commented on in

the safety area? Here are

some topics:

- Involvement in the Risk Management process
- Conduct of safety briefings
- Reporting of accidents
- Reporting of safety problems
- Safety awards
- Enforcement of safety policies
- SAFETY BULLETING BOARDS

The Fort Devens RFTA Reg 385-10 requires units to ensure that safety information is available to every member of the unit. The recommended way of doing this is by having a Safety Bulletin Board. But, bulletin boards are only good if they have the needed information and are kept up-to-date and current. So what should be posted on the Safety Board:

- Command Safety Philosophy
- Safety Officer Contact info
- Appointment memo for unit ADSO/CDSO
- Fort Devens Safety Advisory Council and latest meeting minutes

 Conduct or completion of safety training

And there are others but the point is as the regulations that govern this requirement state: we what to "establish accountability." Keep this in mind as you do your next counseling or report.

### LIGHTNING SAFETY

It is that time of year when summer storms bring lightning. A quick review of actions in lightning situations and including them on your Risk Assessments and safety briefs can help prepare your soldiers for this type of event.

Lightning is the 2d leading cause of weather deaths in the US.

Here are some tips:

- Stay low-ditches and depressions are best
- Avoid vehicles that have canvas covers
- Take shelter under a small tree about 6 feet from the trunk
- Avoid lone trees and poles
- Avoid using radios, phones, or other electronics
- Remove MILES gear and lay your weapon down

Leaders develop a plan and keep soldiers informed.



### **RISK ASSESSMENT**

It cannot be stressed enough—do a risk assessment as part of mission planning!!

Here are some key points:

 Get others involved—if the Safety Off/NCO is the only one completing the risk assessment you are not making the best use of the risk process. Who knows better about the risks in the motor

## SAFETY AWARDS

Did you know that your unit and individual soldiers can earn safety awards?

DA Pam 385-10 Chapter 6 outlines the awards and the requirements and submission process.

For example : The Army Accident Prevention Award of Accomplishment.

Use the correct form: DA form 7566 is no longer current (actually since 2014). Make sure you are using DD Form 2977.

Make sure the risk acceptance is done at the right level. Use Table 4
1 of DA Pam 385-30 to have the right person

 12-months and a major training exercise without a Class A, B, or C accident.

 Initiated by the Commander or the Safety Officer

Is your unit eligible for this award? If not why not set a safety award as a unit goal for this year? make the risk decision.

 Keep a file of the risk assessment you have done. Use then as the start point in the future. More than likely you will be conducting a road convoy again.
