### Deale International Recalls Altafit Smartwatches Due to Risk of Serious Burn Injury and Fire Hazard (Recall Alert)

**Company Recall Date:** 7 August 2025

**Recall Number:** 25-428

**Name of Product:** Altafit af28 Smartwatches

**Hazard:** The smartwatch's wireless charging pad can overheat and ignite, posing a risk of serious burn injury and fire hazard.

**Description:** This recall involves Altafit af28 smartwatches. The recalled smartwatch was sold in gold and silver tones and has a 1.68-inch color touchscreen and two bands, one bejeweled and one mesh. It came in a golden case with a wireless charging pad and cable. "ALTAFIT FCC ID 2BHG8-AF28" is on the back of the watch.

**Remedy:** Consumers should immediately unplug the smartwatch's charging pad and stop charging the recalled smartwatch. Consumers can contact Deale International for instructions on how to receive a free replacement. Consumers will be asked to cut the unplugged charging pad's power cable and email a photo of the charging pad with the cut cable to [altafitrecall@thedeale.com](mailto:altafitrecall@thedeale.com).

**Incidents/Injuries:** Deale International has received 39 reports of smartwatches melting, burning, and catching fire while charging, including six reports of burns to hands and property damage.

### La Ligne Recalls Enfant Bonne Nuit Pajamas Due to Burn Hazard (Recall Alert)

**Name of Product:** La Ligne Enfant Bonne Nuit Pajamas

**Hazard:** The recalled children's pajama sets violate mandatory standards for children's sleepwear flammability, posing a risk of burn injuries to children.

The two-piece long sleeve pajama sets were sold in green with light blue trim, pink with red trim, red with white trim, light blue with red trim, navy with white trim, and white with navy trim. There is a pocket on the left side of the top of the pajama sets. The pajamas were sold in sizes 2, 4, 6, 8 and 10. "La Ligne", "Mini" and the size are printed on the neck label. The words "Made in Peru" and "RN number 150209" are printed on the seam label.

**Remedy:** Consumers should immediately take the recalled children's pajamas away from children, stop using them and contact La Ligne for a full refund. Consumers will be asked to destroy the garments by cutting them in half and disposing them. ### Séfralls Minoxidil Hair Generation Serum Recalled Due to Risk of Serious Injury or Death from Child Poisoning (Recall Alert)

**Company Recall Date:** 7 August 2025

**Recall Number:** 25-426

**Name of Product:** Séfralls Minoxidil Hair Generation Serum

**Hazard:** The hair serum contains minoxidil, which must be in a child-resistant packaging as required by the Poison Prevention Packaging Act. The hair serum's packaging is not child-resistant, posing a risk of serious injury or death from poisoning if the contents are swallowed by young children.

**Hazard:** The recalled children's pajama sets violate the mandatory flammability standards for children's sleepwear, posing a risk of burn injuries or death to children.

The pajama sets were sold in white, pink, yellow, red, blue, beige and green, and feature cartoon patterns. The pajama sets were sold in children's sizes 24M (90), 3T (100), 4T (110), 5T (120) and 6T (130). The brand name and size are printed on the neck label of the pajama top.

**Remedy:** Consumers should stop using the recalled pajamas immediately and contact AliExpress to receive a full refund. Consumers should destroy the pajamas by cutting them in half, then take a photo and dispose of them. ### Monica Vinader Recalls Select 14k Yellow Gold Mini Heart Chain Bracelets, Necklaces, and Stud Earrings Due to High Levels of Cadmium (Recall Alert)

**Name of Product:** Monica Vinader 14k Yellow Gold Mini Heart Jewelry

**Hazard:** The jewelry can contain excess levels of cadmium, which can be toxic if ingested by young children and may cause adverse health effects through long-term skin exposure.

**Description:** This recall involves Monica Vinader 14k Yellow Gold Mini Heart Chain Bracelets (SKU YG-BL-HART-NON), Necklaces (SKU YG-NK-HART-NON) and Stud Earrings (SKU YG-EA-HARS-NON). The recalled jewelry pieces are constructed of 14k yellow gold, contain mini heart pendants and were manufactured in October and November 2024. The chain bracelet measures about 15.3-19 cm, the necklace measures about 41-46 cm and the earrings each measure about .35 cm x 0.4 cm x 0.1 mm.

**Remedy:** Consumers should immediately stop wearing the recalled jewelry, store the jewelry safely out of reach of children, and contact Monica Vinader for a replacement or refund. Consumers can return the jewelry items via prepaid shipping label and receive a replacement or a full refund to their original payment method or, if unavailable, by secure wire transfer. ### Fieldsheer Apparel Technologies Recalls Heated Socks Due to Injury Hazard (Recall Alert)

**Name of Product:** Fieldsheer Heated Socks

**Hazard:** The socks can cause pain and discomfort resulting in burns and blisters when worn during high-intensity activities that generate a combination of heat, excessive friction, moisture and pressure, posing an injury hazard.

**Description:** This recall involves Fieldsheer Apparel Technologies’ heated socks, models MWMS07, MWWS07 and MWMS05. The recalled merino wool socks were sold in black/gray, gray/orange, gray/pink and black/orange color combinations, and in sizes small through extra-large. The socks came with two lithium-ion battery packs and a charging cable. The socks have a battery pocket with either a slit or a black or gray zipper. Model MWMS05 includes a battery pack with model number MW37V122 and a four-button remote control to adjust the heat settings. Models MWMS07 and MWWS07 include Bluetooth battery packs with model number MW37V22-N. The model number can be found printed on the top left corner of the label on the back of the battery pack. The Fieldsheer logo appears in orange on the front of each sock.

**Remedy:** Consumers should immediately stop using the heated socks and contact Fieldsheer Apparel Technologies for a full refund or replacement product of equal value. Consumers should dispose of the lithium-ion battery packs in accordance with applicable laws and regulations.

**Incidents/Injuries:** The firm has received 11 reports of socks causing pain and discomfort, resulting in 4 burns and blisters.

**Hazard:** The recalled toy contains small balls and is intended for children under three years of age, which violates the small ball ban, posing a deadly choking hazard.

### Petmate Recalls Pet Zone Pet Toys Due to Risk of Serious Injury or Death from Ingestion Hazard (Recall Alert)

**Company Recall Date:** 7 August 2025

**Recall Number:** 25-421

**Name of Product:** Pet Zone Laser Pointer & LED Ball Pet Toys

**Hazard:** The recalled pet toys violate the mandatory standard for consumer products containing button cell or coin batteries as required by Reese's Law because the LED-illuminated plastic sphere can break upon impact, making the button cell batteries easily accessible to children, posing an ingestion hazard. Swallowed batteries can cause serious injuries, internal chemical burns and death.

The motion-activated LED ball is clear and measures about 1.6 inches in diameter. The "PET ZONE" logo and "LASER POINTER & LED BALL" are printed on the front of the product packaging and "Item #:15712EAM" on the back.

**Remedy:** Consumers should immediately stop using the recalled pet toys and contact Petmate for a full refund.
