



### LivingCaring Adult Portable Bed Rails Recalled Due to Risk of Serious Injury or Death (Recall Alert)

Company Recall Date: 15 May 2025 Recall Number: 25-282 Name of Product: LivingCaring Adult Portable Bed Rails

Hazard: The recalled bed rails violate federal regulations for adult portable bed rails, posing a serious entrapment hazard and risk of death by asphyxiation. When the bed rails are attached to a bed, users can become entrapped within the bed rail or between the bed rail and the side of the mattress. In addition, the bed rails do not hear the required hazard warning labels.

**Description:** This recall involves LivingCaring branded adult portable bed rails sold for use on adult beds. The bed support railing has a foldable frame made of white metal and black foam padding on the grip handle. The rails are adjustable with the width between about 29 to 41 inches and the height between about 30 to 37 inches. The bed rail comes with a storage bag and a magnetic motion sensor light.

Remedy: Consumers should immediately stop using the recalled adult portable bed rails. # Hazard: The recalled children's pajama sets violate flammability standards for children's sleepwear, posing a burn hazard and risk of serious injuries or death to children.

They have detachable feathers on the wrist and ankle, two front shirt pockets, and buttons down the center seam of the shirt. Styles include BK1105 (Sugar Berry), BK1106 (Tartan), BK1107(Frostbite), BK1108 (Kris Kringle) and BK1109 (Prowl). The size and "BuddyLove" are printed on the neck label. The side seam label displays 100% Polyester fiber content, washing instructions, the Style # and "Made in China".

Remedy: Consumers should stop using the recalled pajamas immediately and contact BuddyLove for information on how to dispose of the product to obtain a full refund or store credit for the original purchase price. Consumers should destroy the garments by cutting them in half and email a photo of the destroyed garment to <u>Recall@buddylove.com</u>. ### Child Safety Gates Recalled Due to Risk of Serious Injury or Death from Entrapment (Recall Alert)

Company Recall Date: 15 May 2025 Recall Number: 23-286 Name of Product: Child Safety Gates

Hazard: The recalled child safety gates violate the federal safety regulation for expansion gates and expandable enclosures because a child's torso can fit through the opening between the gate slat and side wall, a child's torso can fit through the secondary opening, the locking mechanism does not fully engage and/or the gate does not resist a push-out force. These failures pose a risk of serious injury or death due to entrapment and fall hazards.

**Description:** This recall involves multiple child safety gates sold by five different third-party sellers on Amazon.com. The gates have model numbers and cohort information listed on their tracking label, located on the bottom rail. The gates are all made of steel and ABS plastic and were sold in white and black colors. They can be pressure-mounted and/or drill-mounted and vary in several sizes. Some gates have a secondary pet door.

Remedy: Consumers should stop using the recalled gates immediately and contact the third-party seller by email for information on how to dispose of the product and submit proof of destruction to obtain a full refund. The third-party sellers and Amazon are contacting all known purchasers directly.

#### FigetThings Recalls Chill Pill Magnetic Haptic Fidget Toys Due to Risk of Serious Injury or Death from Ingestion (Recall Alert)

Company Recall Date: 15 May 2025 Recall Number: 23-285 Name of Product: Chill Pill Magnetic Haptic Fidget Toys Red Bumpy

Hazard: The recalled magnetic fidget pill toy violates the mandatory federal regulation for magnets, posing an ingestion hazard to children. When high-powered magnets are swallowed, the ingested magnets can attract each other, or another metal object, and become lodged in the digestive system. This can result in perforations, twisting and/or blockage of the intestines, infection, blood poisoning and death.

The magnets are interchangeable with other FidgetThings magnetic fidget pill toys of different colors and textures. The magnetic fidget pill toy was sold encased in a mock prescription bottle with a mock label. The magnets make a clacking sound when brought together. The magnetic fidget pill toy measures about two inches and the mock prescription bottle measures about 3 inches. The mock prescription bottle has "3DPrint Bumpy" printed on the label.

Remedy: Consumers should stop using the magnetic fidget pill toys immediately and take them away from children. ### Polaris Recalls Ranger Recreational Off-Road Vehicles Due to Injury Hazard (Recall Alert)

Company Recall Date: 15 May 2025 Recall Number: 23-284 Name of Product: Model Year 2023-2025 Ranger XP 1000 NorthStar and Ranger XP 1000 NorthStar Crew Recreational Off-Road Vehicles (ROVs)

Hazard: The lower seat belt anchor fasteners were not properly tightened, which can result in the seat belt separating from the vehicle frame, failing to protect riders. Without that protection, riders can be ejected from the vehicle in a crash, posing an injury hazard.

**Description:** This recall involves certain VINs of Polaris Model Year 2023-2025 Ranger XP 1000 NorthStar and Ranger XP 1000 NorthStar Crew ROVs. The recalled vehicles were sold in black, blue, brown, camouflage, gray, orange, red, tan and white. The vehicles were sold in three and six-seat configurations and have "POLARIS" stamped on the front grille. The VIN is printed on the left rear frame (on the driver's side of the vehicle) under the cargo box.

Remedy: Consumers should immediately stop using the recalled ROVs and contact an authorized Polaris dealer to schedule a free inspection and repair at the dealer's location. Polaris advises that consumers may continue to operate the recalled ROVs prior to inspection and repair at the dealer, only if they conduct an inspection by following the Seat Belt Fastener Verification Instructions located on the firm's website. To continue operating the recalled ROVs prior to getting the repair, the fasteners must be secure where the seat belt anchor is attached to the vehicle frame. Polaris has contacted registered owners directly.

Incidents/Injuries: The firm has identified two vehicles with loose seat belt fasteners. No injuries have been reported.









#### Fat Brain Recalls Rollers Tile Toys Due to Magnet Ingestion Hazard (Recall Alert)

When high-powered magnets are swallowed, the ingested magnets can attract each other, or other metal objects, and become lodged in the digestive system. This can result in perforations, twisting, and/or blockage of the intestines, infection, blood poisoning, and death.

The remote control for the clock has a lithium coin battery that can be easily accessed by children, posing an ingestion hazard. In addition, the recalled products do not have the warnings required under <u>Reese's Law</u>. When button cell or coin batteries are swallowed, the ingested batteries can cause serious injuries, internal chemical burns and death.

Hazard: The Submersible RGB LED Light's remote control has a lithium coin battery that can be easily accessed by children, posing an ingestion hazard. Hazard: The highchairs pose a deadly fall hazard to babies because the restraint system is not attached to the product and the locks or latches can fail. In addition, the highchairs pose an entrapment hazard because the opening between the seat and tray is large enough that a child can become entrapped in it. These are violations of the federal regulations for highchairs.
