#### In My Jammers Recalls Button Flare Pajama Sets Due to Burn Hazard (Recall Alert)

**Company Recall Date:** 11 September 2025

**Recall Number:** 25-462

**Name of Product:** In My Jammers Button Up Flare Pajama Sets

**Hazard:** The recalled children's pajama sets violate mandatory standards for children's sleepwear flammability, posing a risk of burn injuries to children.

**Description:** This recall involves In My Jammers-branded children's button up flare sets. The recalled pajama sets consist of a 95% viscose and 5% spandex short-sleeved shirt with buttons and matching flared pants. The pajama sets were sold in the following patterns: bows, swans, cherry, croissant and coffee, kiss, and floral prints in sizes 2T through 6T, 7/8, and 9/10. "In My Jammers" and the size are printed on the neck label of the pajama top.

**Remedy:** Consumers should stop using the recalled pajama sets immediately and contact My Jammers for a full refund or store credit. Consumers should destroy the pajamas by cutting them in half, then take a photo of the destroyed pajamas and email it to [recall@inmyjammers.com](mailto:recall@inmyjammers.com), then dispose of the pajamas.

#### Shierdu Children's Toys Recalled Due to Risk of Serious Injury or Death from Choking Hazards (Recall Alert)

**Company Recall Date:** 11 September 2025

**Recall Number:** 25-461

**Name of Product:** Children's Wooden Cactus Toys

**Hazard:** The recalled toy is intended for children under three years of age and contains small parts, which violates the small parts ban, posing a deadly choking hazard.

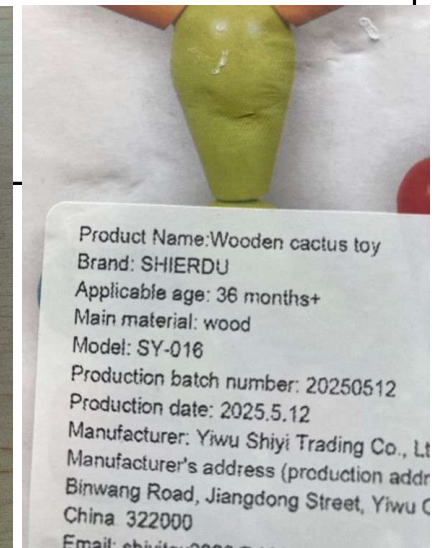
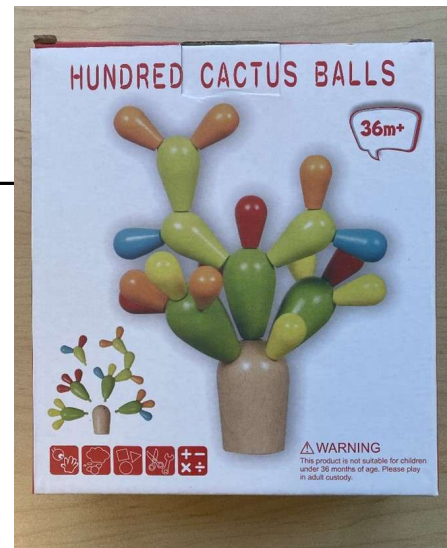

**Description:** This recall involves Shierdu's children's wooden building block cactus toys. The toys consist of 28 pieces: a natural wood color base with holes and wooden, bulbous segments with pegs that are painted yellow, light green, dark green, blue, red and gray and attach to each other to form a cactus. "SHIERDU" and model number "SY-016" are printed on the label located on the product's packaging.

**Remedy:** Consumers should immediately stop using the recalled toys and contact Yiwu Shiyi Trading for a full refund. Consumers will be asked to throw the product away and send a photo of the disposed product to [yizhao2025@outlook.com](mailto:yizhao2025@outlook.com).

#### **Blueroot Health Recalls Bottles of Bariatric Fusion Iron Multivitamins Due to Risk of Serious Injury or Death from Child Poisoning (Recall Alert)**

**Company Recall Date:** 11 September 2025

**Recall Number:** 25-460

**Name of Product:** Bariatric Fusion Iron Multivitamin Bottles

**Hazard:** The recalled multivitamins contain iron which must be in child-resistant packaging, as required by the Poison Prevention Packaging Act. The recalled packaging of the iron-containing multivitamins violates the federal standard for child-resistant packaging because the bottle caps are not child-resistant, posing a risk of deadly poisoning if the contents are swallowed by young children.

**Description:** This recall involves two types of Bariatric Fusion dietary supplement bottles: high ADEK multivitamin capsules (90 and 270-count bottles) and One Per Day bariatric multivitamin capsules (90-count bottle), both with 45mg of iron. The recalled bottles are white and orange. Only bottles with smooth cap tops that lack the “push down & turn” embossed lettering are included in this recall. The Bariatric Fusion logo is printed on the front of the bottles. Lot number 0066J4, 0065J4, 0453B5 or 0370B5 is printed on the bottom of the bottles..

**Remedy:** Consumers should immediately secure the recalled bottles out of sight and reach of children, and contact Blueroot Health for information on how to obtain a free child-resistant replacement cap.

#### **Epoca International Recalls Paris Hilton Mini Beauty Fridges Due to Fire and Burn Hazards (Recall Alert)**

**Company Recall Date:** 11 September 2025

**Recall Number:** 25-459

**Name of Product:** Paris Hilton Mini Beauty Fridges

**Hazard:** The recalled mini fridges' electrical switch can short circuit, causing it to overheat, posing a fire and burn hazard.

**Description:** This recall involves the Paris Hilton Mini Beauty Fridge sold in a 4-liter model in pink, white, aqua and hot pink and in a 10-liter model in pink and white. A label with the model number and serial number is located on the back of the unit for the 4-liter model and on the bottom of the unit for the 10-liter model. Paris Hilton branding is on the door in the right lower corner for most units, and in the top middle for some units. Only units manufactured prior to August 2024 with the serial numbers and ranges shown [here](#) are included in this recall.

**Remedy:** Consumers should immediately stop using the recalled Paris Hilton Mini Beauty Fridge, unplug the unit, and register for the recall at [www.epoca.com/minifridgerecall](http://www.epoca.com/minifridgerecall). To receive a refund, consumers will have to fill out the online form and submit three photographs; one should be the refrigerator's door with the word "RECALL" written on it using a permanent marker, the second photograph should be of the label on the unit showing the model number and serial number and the last photograph should be of the cut, unplugged cord. Consumers should discard the recalled fridge according to local and state regulations.

**Incidents/Injuries:** The firm is aware of 27 reports of the mini fridge overheating and catching on fire. No injuries have been reported. Property damage has included damage to the unit and surrounding surfaces.

**Sold At:** Walmart, Ross and online at Walmart.com and Amazon.com and other e-commerce sites from **November 2022 through July 2025. The 4-liter model sold for approximately \$30, and the 10-liter model sold for approximately \$60.**
