#### Tesla Recalls Powerwall 2 AC Battery Power Systems Due to Fire and Burn Hazards (Recall Alert)

**Company Recall Date:** 13 November 2025

**Recall Number:** 26-092

**Name of Product:** Certain Tesla Powerwall 2AC Battery Power System

**Hazard:** The lithium-ion battery cells in certain Powerwall 2 systems can cause the unit to stop functioning during normal use, which can result in overheating and, in some cases, smoke or flame and can cause death or serious injury due to fire and burn hazards.

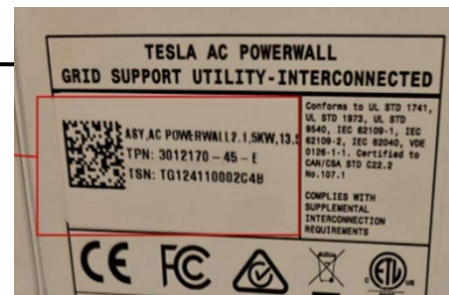

**Description:** This recall involves certain Tesla Powerwall 2 units, fully-integrated AC battery systems used for energy storage for self-consumption, time-based control, and backup power. Model number “Powerwall 2” is printed on the nameplate label on the side of the unit.

**Remedy:** Consumers should ensure their Powerwall 2 system is online and check the Tesla App for a notification about whether their unit is included in the recall. Tesla has remotely discharged (or removed energy from the battery of) affected Powerwall 2 systems that are online to prevent overheating until the replacement is installed.

**Incidents/Injuries:** The firm has received 22 reports of overheating, including six reports of smoking and five reports of fire resulting in minor property damage. No injuries have been reported.

#### **Zigjoy Sleep Sacks with Feet Recalled Due to Risk of Serious Injury or Death from Burn Hazard (Recall Alert)**

**Company Recall Date:** 13 November 2025

**Recall Number:** 26-091

**Name of Product:** Zigjoy Toddler sleep Sacks with Feet

**Hazard:** The recalled sleep sacks violate the mandatory flammability standard for children's sleepwear, posing a burn hazard and risk of injury or death to children.

**Description:** This recall involves Zigjoy-branded children's one-piece sleep sacks with feet in blue with an excavator print or pink with a bunny print. The sleep sacks were sold in sizes S, M, and L. "100% cotton" and the garment size are printed on a sewn-in side seam label.

**Remedy:** Consumers should immediately stop using the sleep sacks and contact Zigjoy-US for a full refund. Consumers should cut the sleep sacks in half, take a photo of the destroyed garments and email it to [zjoy-us@outlook.com](mailto:zjoy-us@outlook.com) to receive the refund.

#### Belkin Recalls Portable Power Banks and Wireless Charging Stands Due to Fire and Burn Hazards (Recall Alert)

**Company Recall Date:** 13 November 2025

**Recall Number:** 26-090

**Name of Product:** Portable Power Banks and Wireless Charging Stands

**Hazard:** The lithium-ion battery in the power banks and charging stands can overheat, posing fire and burn hazards to consumers.

**Description:** This recall involves charging stands with model number MMA008 and power banks with model numbers BPB002 and PB0003. Model number “MMA008” is printed on the bottom of the charging stand. Serial numbers (14 digits) starting with “57X” are included in this recall and are also printed on the bottom of the charging stand. Model number “BPB002” is printed on the back top of the power bank. Serial numbers (14 digits) starting with “35S” are included in this recall and are also printed on the back of the power bank. Model number “PB0003” is printed on the back of the power bank. All serial numbers are included in this recall. Both the charging stands and BPB002 power banks were sold in black. The PB0003 power banks were sold in black or white.

**Remedy:** Consumers should immediately stop using the recalled power banks and charging stands and contact Belkin to receive a full refund or store credit. Consumers should submit photos showing the front and back of the product with their recall submission form. Consumers can receive a full refund for the amount on the purchase receipt, if provided. If no receipt is provided, consumers can receive the average sales price for the model. Alternatively, consumers can choose to receive a Belkin store credit worth 20 percent more than the average sales price of the model.

**Incidents/Injuries:** The firm has received one report of a fire incident in the U.S. (and 15 reports internationally). Two minor burn injuries and property damage totaling \$37,765 have been reported outside of the U.S.

**Sold At:** Best Buy, Target, Walmart and other stores nationwide and online at Belkin.com, Amazon.com and on Tiktok from **August 2020 through August 2025 for between \$29 and \$180.**

#### Great Lakes Wholesale International Recalls Select Battery Packs Due to Battery Ingestion (Recall Alert)

**Company Recall Date:** 13 November 2025

**Recall Number:** 26-089

**Name of Product:** Great Lakes Select Button Cell and Coin Batteries

**Hazard:** The button cell and lithium coin batteries are not in child-resistant packaging and do not bear the warning labels required under Reese's Law. If a child swallows button cell or coin batteries, the ingested batteries can cause serious injuries, including internal chemical burns and death.

**Remedy:** Consumers should stop using the Great Lakes Select Battery Packs immediately, place them in an area that children cannot access and contact Great Lakes Wholesale International to obtain a full refund.

#### **Trek Recalls Bicycles with Coaster Brakes and Replacement Rear Wheels Due to Crash Hazard (Recall Alert)**

**Company Recall Date:** 13 November 2025

**Recall Number:** 26-088

**Name of Product:** Trek and Electra-branded Bicycles with Coaster Brakes and Replacement Rear Wheels with Coaster Brakes

**Hazard:** The coaster brakes can fail to engage, resulting in the rider losing control, posing a crash hazard.

**Description:** This recall involves certain Trek and Electra-branded bicycle models with coaster brakes and replacement rear wheels. The bikes were sold in a variety of colors including red, flamingo pink, dark aquatic, Mulsanne blue, volt yellow, pink frosting, Miami green, lithium gray, viper red, purple abyss, buttercup, pixie blue and blue. To determine if your bicycle or replacement rear wheel is included in this recall, enter your bicycle's serial number in the look-up tool at [https://www.trekbikes.com/us/en\\_US/coasterbrake-recall-inquiry/](https://www.trekbikes.com/us/en_US/coasterbrake-recall-inquiry/). The serial number is printed under the bottom bracket between the pedals and starts with the letters, “WTU.”

**Remedy:** Consumers should immediately stop using the recalled bicycles with coaster brakes and related replacement rear wheels and contact an authorized Trek or Electra dealer to schedule a free repair at the dealer.

**Incidents/Injuries:** None reported

**Sold At:** Trek and Electra authorized retailers nationwide, in stores and online, as well as at Trek.com from **August 2023 to September 2025 for between \$300 and \$660 for the bikes and between \$66 and \$77 for the replacement wheels.**

#### Zippee Silicone Activity Toys Recalled Due to Risk of Serious Injury or Death from Choking (Recall Alert)

**Company Recall Date:** 13 November 2025

**Recall Number:** 26-086

**Name of Product:** Zippee Activity Toys

**Hazard:** The recalled silicone activity toys contain spherical ends that can reach the back of the throat, posing a serious choking hazard to children.

**Description:** This recall involves the Zippee children's activity silicone toy. The body of the toy is a teal flexible silicone cylinder with holes where six different color silicone strings can be pulled. Five of the six silicone strings contain a spherical ball attached to the end of the string. The recalled toy may have the date codes in MMDDYY format ranging from 030620 to 110823 marked inside the toy's silicone cylinder body.

**Remedy:** Consumers should stop using the recalled toy immediately, take it away from children and contact Mobi Games to receive a full refund. Consumers will be asked to register their product online by first confirming they have an affected version with spherical ends on the strings and then by providing a photo of the destroyed toy. Consumers will be directed to destroy the toy by cutting the spherical ends off the silicone strings and writing their initials and date on the teal cylinder.

**Incidents/Injuries:** Mobi Games is aware of one incident involving a child placing the toy in his/her mouth and gagging, resulting in vomiting and choking. The child was released from medical care with no further injuries.

#### **Bettina Doll Sets Recalled Due to Risk of Serious Injury or Death from Battery Ingestion (Recall Alert)**

**Company Recall Date:** 13 November 2025

**Recall Number:** 26-085

**Name of Product:** Bettina doll Set with Magic Light Unicorn

**Hazard:** The doll sets violate the mandatory standard for toys because the battery compartment of the unicorn contains button cell batteries that can be easily accessed by children. When button cell or coin batteries are swallowed, the ingested batteries can cause serious injuries, internal chemical burns and death.

**Description:** This recall involves Bettina Doll Set with Magic Light Unicorn. The Magic Light Unicorn is white with multi-colored hair and a pink saddle, and the doll has a pink dress. The unicorn is 10 inches long and 9.5 inches tall, and the doll is 12 inches tall. There is a pink toy hairbrush included with the set.

**Remedy:** Consumers should immediately take the doll sets away from children, stop using the recalled toys and remove and properly dispose of the batteries. Consumers will be asked to throw the unicorn away and send a photo of the disposed product to [bettinaaftersales@outlook.com](mailto:bettinaaftersales@outlook.com) to receive a full refund.
