Peg Perego Recalls Tatamia 3-in-1 Recliners, Swings and Highchairs Due to Risk of Suffocation (Recall Alert)

Name of Product: Peg Perego Tatamia 3-in-1 Recliner, Swings and Highchairs

Hazard: The 3-in-1 products pose a suffocation risk because they were marketed for infant sleep, and they have an incline angle greater than 10 degrees, in violation of the Infant Sleep Products Rule and Safe Sleep for Babies Act. In addition, the products fail to meet mandatory warning requirements under the highchair standard.

Sanven Technology Recalls Vevor Handrails Due to Injury Hazard (Recall Alert)

Name of Product: Vevor Single Post Handrails

Hazard: The handrails' welding can break while a consumer is holding onto the handrail when stepping down a flight of stairs, posing an injury hazard.



Description: This recall involves Vevor's wrought iron single post handrails for one or two step stairs. The handrails were sold in black (model numbers TFBGWXLZHS1JGNHKIV0 and LTFSSHSDZJSFS001V0), white (model number LTFSBSDDZJSFS0001V0) and silver (model numbers LTFS2BBXGMLFS0001V0, LTFS1BBXGMLFS0001V0 and LTFSBSHXDDZJSFS01V0). "Vevor" is printed on a label located near the bottom of the handrail and the model number is on the label of the product's packaging.

Remedy: Consumers should stop using the recalled handrails immediately and contact Vevor for a full refund. Vevor will provide pre-paid shipping labels for the consumers to return the handrails. Alternatively, consumers can provide photographic evidence of disposal or destruction of the product to recalling@vevor.com. Vevor is contacting all known purchasers directly.

Incidents/Injuries: Vevor has received five reports of the handrails breaking, resulting in injuries, including one head injury.

Boyro Baby Walkers Recalled Due to Risk of Serious Injury or Death from Fall Hazard (Recall Alert)

Company Recall Date: 26 June 2025

Recall Number: 25-361

Name of Product: Boyro Baby Walkers

Hazard: The recalled baby walkers violate the federal safety standard for infant walkers because they can fit through a standard doorway and fail to stop at the edge of a step as required, posing a risk of serious injury or death due to a fall hazard. In addition, the baby walkers' brake pads contain levels of lead that exceed the federal lead content ban that are prohibited in children's products by the Federal Hazardous Substances Act. Lead is toxic if ingested by young children and can cause adverse health effects.

Description: This recall involves Boyro Baby's baby walkers, model number US-B01. The plastic walkers were sold in black, blue and gray with five levels of height adjustments. They have a black or gray rotating seat, a matching footpad, six wheels and four removable toys (an owl, a flower, an arch with a ball and a three-button panel that plays music and lights up.) "Ready To Ride" appears on a label on one of the walker's legs and the height-adjustment buttons are on another leg. "Boyro Baby" and the model number are printed on the tracking label, located under the seat cushion.

Remedy: Consumers should stop using and disassemble the recalled baby walkers immediately and contact Boyro Baby for instructions on receiving a full refund. Consumers will be asked to destroy the disassembled baby walker and email three photos of the destroyed product to boyrobaby@outlook.com. Once the three photos have been received, Boyro Baby will issue a refund. Boyro Baby and Amazon are contacting all known purchasers directly.

LED Fireplace Lanterns Recalled Due to Risk of Serious Injury or Death from Ingestion Hazard (Recall Alert)

Company Recall Date: 26 June 2025

Name of Product: LED Fireplace Lanterns

Hazard: The recalled lanterns violate the mandatory federal standard for consumer products containing button cell or coin batteries because the lithium coin battery in the remote control can be accessed easily by children, posing an ingestion hazard. In addition, the recalled products do not have the warning labels required under Reese's Law. When button cell or coin batteries are swallowed, the ingested batteries can cause serious injuries, internal chemical burns and death.

Some models have a metal fence, some are free standing and others have four legs. The product includes the lantern, USB power cable, a remote control and one preinstalled CR2025 lithium battery in the remote control. The model number is printed on top of the box.

Remedy: Consumers should immediately stop using and remove the battery from the lanterns' remote control and place it in an area that children cannot access. Bell Sports Recalls Bicycle Helmets Due to Risk of Head Injury (Recall Alert)

Name of Product: Bell Sports Bicycle Helmets

Hazard: The recalled helmets do not comply with the impact requirements of the Consumer Product Safety Commission's (CPSC) mandatory federal safety standard for bicycle helmets. The helmets can fail to protect the user in the event of a crash, posing a risk of head injury.

The helmets were sold in the following colors or color combinations: blue, green, purple, red, pink, black/blue, green/black, pink/green, pink/purple, pink/white, purple/white, red/black, pink/mint or multi-color; and have various designs, including checkers, lines, polka dots, rainbows and swirls. The model name, the model number, and the manufacture date in MM/YY or M/YY format can be found on a sticker inside the helmet.

Hazard: The bit can break during use, posing a fall hazard to rider.



AVB-171), a 7 1/4" shank with a decorative silver design and swivel port mouthpiece; Avila Byron Swivel Port (model no. AVB-612), an 8" Gunmetal shank, swivel port mouthpiece; Avila Phoenix Swivel Port (model no. AVB-621), an 8" cheek with a silver and copper decorative sunflower at the top of the shank, and silver bar design on remainder of cheek; and Avila Sunflower Swivel Port (model no. AVB-222), a 7" shank with a decorative silver and copper floral design, swivel port mouthpiece.

Total Saddle Fit Recalls Western Saddle Cinches Due to Fall and Injury Hazards (Recall Alert)

Name of Product: Shoulder Relief Saddle Cinches

Hazard: The cinch can come apart and cause the saddle to fall off, posing fall and injury hazards to the rider.

Description: This recall includes Shoulder Relief Cinches which are designed to hold the saddle in place on the horse. The leather cinch comes in black and brown colors and measures between 24 and 36 inches. The Total Saddle Fit name is located near the buckle on the cinch. This recall only includes cinches sold prior to August 2021, which can be identified by a Shoulder Relief Cinch with a round buckle and no center elastic on the cinch.

Remedy: Consumers should immediately stop using the recalled Shoulder Relief Cinch and contact Total Saddle Fit for a free replacement, and instructions on how to return the original cinch (pre-paid shipping label will be provided). Total Saddle Fit is contacting all known purchasers.

Incidents/Injuries: The firm has received 19 reports of the cinch coming apart and the saddle falling off, including one report of a rider fracturing their ribs.

DR Power Recalls Lithium-Ion Battery Packs Due to Fire and Burn Hazards (Recall Alert)

Company Recall Date: 26 June 2025

Name of Product: DR Power LiPRO rechargeable lithium-ion battery packs (5.0 Ah)

Hazard: The recalled battery packs can short-circuit and ignite, posing fire and burn hazards to consumers.

Description: This recall involves 62-volt 5.0 Ah LiPRO rechargeable lithium-ion battery packs for use with DR Power brand battery-powered products, such as lawnmowers, trimmers and snow throwers. The products include stand-alone battery packs with model number 414240, and removable battery packs included with DR Power outdoor yard equipment items with model numbers 524340, SB11022XEN, T4X3026XEN, T4X3062XENR, CE75021XEN0 and CE77021XEN0. Information containing the model number for the battery pack ("41424") is located on the battery pack's label. The LiPRO and DR Power logo are on the front and side panels of the battery pack.

Remedy: Consumers should immediately stop using the recalled battery packs and contact DR Power for a pro-rated refund, based on the battery's age. Consumers will need to show proof of the battery pack's destruction by uploading two photographs in accordance with the destruction instructions (provided on the firm's recall website) and filling out the recall form online at <https://www.drpower.com/5AHB-recall>. If consumers choose to dispose of the recalled battery pack's lithium-ion battery, it should be done in accordance with local and state regulations.

Incidents/Injuries: The firm has received two reports of incidents of fire and/or overheating. No injuries have been reported.

iHerb Recalls Bottles and Blister Packs of California Gold Nutrition Iron Supplements Due to Risk of Serious Injury or Death from Child Poisoning (Recall Alert)

Company Recall Date: 26 June 2025

Name of Product: California Gold Nutrition Iron Supplements: Daily Prenatal Multi, Ultamins Women's Multivitamin, and Ultamins Women's 50+ Multivitamin

Hazard: The recalled dietary supplements contain iron, which must be in child-resistant packaging, as required by the Poison Prevention Packaging Act. The iron-containing dietary supplement packages violate the federal standard for child-resistant packaging because the bottles and blister packs are not child-resistant, posing a risk of deadly poisoning, if the contents are swallowed by young children.

Both products contain 60 capsules in foil within the packaging. Name of Product: Converta camping cots and Converta camping suspension stretchers

Hazard: The backrest fold mechanism can pinch consumers' fingers, posing laceration and amputation hazards.

Description: This recall involves Coleman Converta camping cots with model numbers 2000003077 and 2000020282, and Coleman Converta camping suspension stretchers with model number 2000020290. The model numbers are printed on a hang tag attached to the frame. The camping cots and suspension stretchers have tan or white fabric with the Coleman logo printed on the fabric, and black steel frames with adjustable seatbacks and leg positions.

Remedy: Consumers should immediately stop using the recalled camping cots and suspension stretchers and contact The Coleman Company for a free repair kit, including installation instructions.

Incidents/Injuries: The firm has received seven reports of the seatback adjustment mechanism pinching consumers' fingers, including two reports of fractured fingers.
