MEMORANDUM FOR All Service Members, Fort Eisenhower, GA

SUBJECT: Off-Limits Establishments Policy and Order

1. REFERENCE: Army Regulation 190-24; OPNAVINST 1620.2A; AFI 31-213; MCO 1620.2D; COMDTINST 1620.1E (Armed Forces Disciplinary Control Board and Off-Installation Liaison and Operations), 27 July 2006.

2. PURPOSE: To establish local policy on areas declared off-limits by the Commanding General, U.S. Army Cyber Center of Excellence and Fort Eisenhower, through the Armed Forces Disciplinary Control Board process and to order military personnel to comply with this policy.

3. POLICY: The following establishments in the surrounding area have been placed off-limits to all military personnel assigned, attached, or performing duties at Fort Eisenhower, GA.

a. Off-limits locations:

- (1) Aficionados of Augusta, 307 8th Street, Augusta, GA 30901.
- (2) Augusta Kratom and CBD, 337 Belair Road, Martinez, GA, 30907.
- (3) Lotto Smile E-Cig, 4110 Windsor Spring Road, Hephzibah, GA, 30815.
- (4) Outkast Motorcycle Club, 120 Sand Bar Ferry Road, Augusta, GA 30909.

(5) Ragweed's DIY Vaping Supplies, Suite 9304 218 S Belair Road, Martinez, GA 30907.

- (6) Smoke Life, 3402 Wrightsboro Road, Suite B, Augusta, GA, 30909.
- (7) The CBD Store 4015 Washington Road, Suite B, Augusta GA, 30907.
- (8) The CBD Store, 4958 Steiner Way, Grovetown, GA, 30813.
- (9) Trip 3 Smoke Shop, 3336 Wrightsboro Road, Suite 4, Augusta, GA 30909.

b. Punitive Provisions. All military personnel subject to the UCMJ, including Reservists on active duty for training and National Guard Soldiers in a Title 10 status, are ordered not to visit the listed establishments. This is a lawful general order, violations of which may be punished under Article 92, UCMJ. This restriction does not apply to law enforcement and other officials acting in their official capacities for law enforcement or AFDCB purposes in accordance with AR 190-24.

c. Publication. Commanders at all levels are responsible for ensuring that this policy is publicized and effectively communicated to all military personnel within their commands. This policy will be conspicuously displayed with other similar policies, and newly assigned Soldiers, including those at Fort Eisenhower for temporary duty, will be briefed on its provisions.
