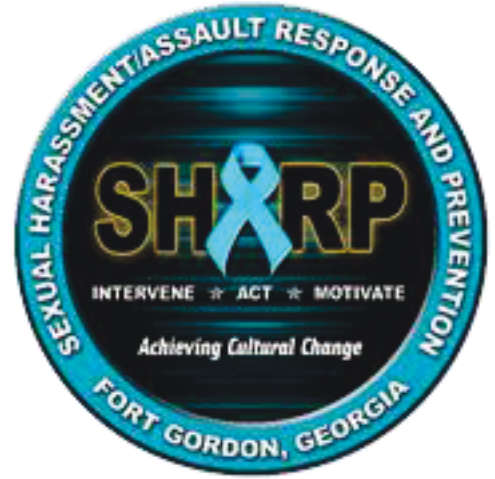

## The Teal Hash Report contains Sexual Assault Related Courts-Martial Verdicts of Trial

In an effort to ensure that the Sexual Assault Prevention and Response (SAPR) information is disseminated to the CCoE and Ft Gordon personnel, the Teal Hash is published quarterly. The verdicts published in this Teal Hash focus on the Second Judicial Circuit (Southeast) and include Fort Bragg, Fort Stewart, Fort Gordon, Fort Jackson, and Fort Benning.

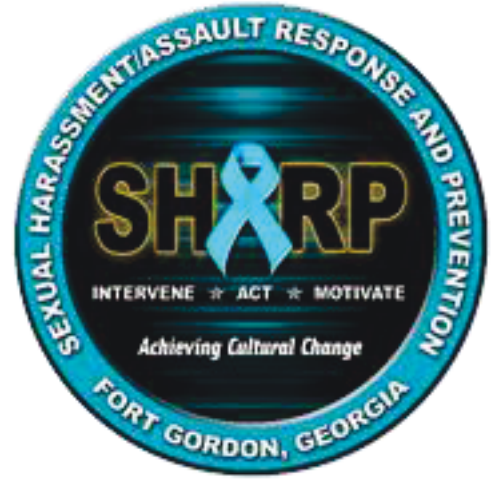

## TEAL HASH JULY 2016

### Sexual Assault Related Courts-Martial Results of Trial

#### Fort Bragg, North Carolina, July 6

**Name:** Staff Sgt. Rex A. Wilhite

**Conviction:** By a military judge, pursuant to his pleas, of two specifications of sexual assault of a child, three specifications of sexual abuse of a child, one specification of producing child pornography and two specifications of possessing child pornography.

**Sentence:** Reduced to the grade of E-1, forfeit all pay and allowances, confined for 37 years, dishonorable discharge. As part of an offer to plead guilty, a pre-trial agreement limited confinement to 30 years.

#### Fort Stewart, Georgia, July 14

**Name:** Spc. Cornelius D. Bailey

**Conviction:** By a military judge, pursuant to his plea, of one specification of sexual assault.

**Sentence:** Confined for 18 months, dishonorable discharge.

#### Fort Benning, Georgia, July 18

**Name:** Sgt. James D. Leggett Jr.

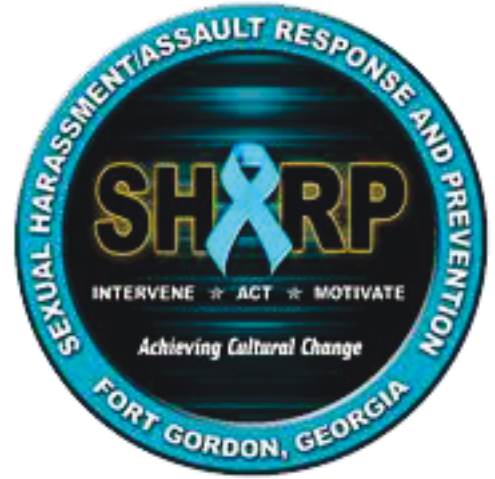
**Conviction:** By a military judge, pursuant to his pleas, of one specification of abusive sexual contact, one specification of wrongfully photographing the private area of a soldier without her consent, one specification of wrongfully broadcasting a recording of the private area of a soldier recorded without her consent, one specification of assault and one specification of assault consummated by a battery.

**Sentence:** Reduced to the grade of E-1, confined for nine months, bad-conduct discharge.

## TEAL HASH AUGUST 2016

### Sexual Assault Related Courts-Martial Results of Trial

#### Fort Bragg, North Carolina, Aug. 1

**Name:** Sgt. Daren L. Humphrey

**Conviction:** By a military judge, pursuant to his pleas, of one specification of violating a lawful general order, one specification of sexual assault of a child and one specification of sexual abuse of a child.

**Sentence:** Reduced to the grade of E-1, confined for two years, dishonorable discharge.

#### Fort Bragg, Aug. 4

**Name:** Staff Sgt. Lawrence P. Muscat

**Conviction:** By a military judge, contrary to his pleas, of two specifications of abusive sexual contact with a child, one specification of communicating indecent language to a child, three specifications of sodomy, three specifications of assault consummated by a battery upon a child under 16 years and one specification of communicating a threat. Acquittal: One specification of communicating indecent language to a child, one specification of sexual abuse of a child, one specification of aggravated assault with a dangerous weapon and one specification of assault consummated by a battery upon a child under 16 years.

**Sentence:** Reduced to the grade of E-1, confined for 20 years, dishonorable discharge.

#### Fort Bragg, Aug. 5

**Name:** Spc. Jermel L. Cleveland

**Conviction:** By a military judge, pursuant to his pleas, of two specifications of sexual assault.

**Sentence:** Reduced to the grade of E-1, forfeit all pay and allowances, confined for 19 months, dishonorable discharge. As a part of an offer to plead guilty, a pretrial agreement limited confinement to 18 months.

#### Fort Bragg, Aug. 12

**Name:** Sgt. Brian M. Andrews

**Conviction:** By a military judge, pursuant to his pleas, of two specifications of failure to obey a lawful general regulation, one specification of false official statement and one specification of sexual assault.

**Sentence:** Confined for 12 months, bad-conduct discharge.

#### Fort Bragg, Aug. 24

**Name:** Sgt. Travis Hernandez

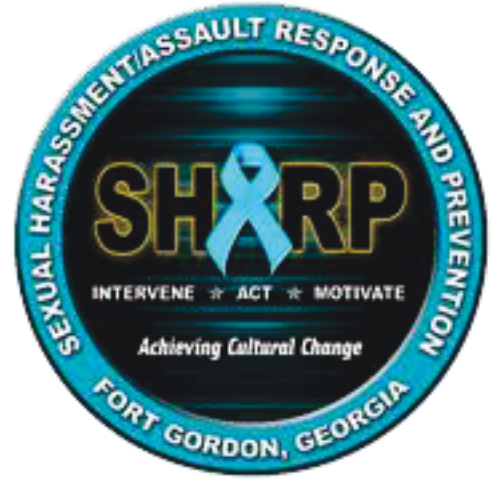
**Conviction:** By a panel of officers and enlisted members, pursuant to his plea, of one specification of disobeying a lawful general regulation. The accused was convicted, contrary to his pleas, of one specification of maltreatment of a subordinate and one specification of sexual assault. Acquittal: One specification of maltreatment of a subordinate and one specification of indecent exposure.

**Sentence:** Reduced to the grade of E-1, forfeit \$1,566.90 pay per month for three months, confined for 90 days, dishonorable discharge

## TEAL HASH SEPTEMBER 2016

### Sexual Assault Related Courts-Martial Results of Trial

#### Fort Stewart, Sept 7

**Name:** Pfc. Kevin L. West

**Conviction:** By a military judge, of three specifications of sexual abuse of a child, two specifications of knowingly receiving child pornography, and one specification of enticing a child to engage in sexually explicit conduct for the purpose of producing child pornography.

**Sentence:** Reduced to the grade of E-1, to forfeit all pay and allowances, to be confined for three years, and to be discharged from the service with a dishonorable discharge.

#### Fort Stewart, Sept 23

**Name:** Spc. Dominique D. Goldsborough

**Conviction:** By a military panel of one specification of disobeying a commissioned officer. He was acquitted of one specification of false official statement, two specifications of sexual assault, one specification of aggravated assault, and two specifications of assault consummated by a battery.

**Sentence:** Was sentenced to be reprimanded and to be reduced to the grade of E-3.

#### Fort Gordon, Sept 28

**Name:** Spc. Joshua W. James

**Conviction:** By a military judge, of one specification of viewing child pornography and one specification of possessing child pornography.

**Sentence:** Reduced to the grade of E-1, to forfeit all pay and allowances, to be confined for five months, and to be discharged from the service with a bad-conduct discharge.
