SUBJECT: Fort Lee Environmental Policy

References:

- a. AR 200-1, Environmental Protection and Enhancement, 13 December 2007.
- b. International Organization for Standardization, ISO 14001, Environmental Management Standard, 2004.
- 2. Purpose: To inform Fort Lee personnel that I am committed to achieving our mission while protecting the environment, reducing our environmental impact, ensuring compliance, and continuing to improve. Furthermore, complying with environmental standards, regulations, and policies is mandatory.
- 3. Background: The US Army's strategy to maintain environmental readiness is to integrate environmental values into the US Army mission with Mission Integration Environmental Management System (MI-EMS) in order to sustain readiness, improve Soldiers' quality of life, strengthen community relationships, and provide sound stewardship of resources.
- 4. Applicability: All military, civilian, contractor, and visiting personnel on Fort Lee.
- 5. Policy: In order to protect known and unknown environmental resources, all personnel working on Fort Lee shall: take the Environmental General Awareness Training and job-specific training, know proper spill response procedures, obtain applicable permits, fulfill permit requirements, maintain records, participate in audits and inspections, include Environmental Special Conditions (ESC) in contracts, reduce hazardous material usage, purchase green products, meet energy, water, and waste diversion goals, adhere to Environmental Management Plans, and obtain signed Records of Environmental Consideration (REC) prior to starting new projects, installing new equipment, and maintaining facilities and land areas.
- a. All non-residential universal and hazardous waste shall be submitted to Directorate of Public Works Environmental Management Division (DPW-EMD) for processing and disposal at Building 7130. Hazardous waste manifests shall only be signed by properly trained personnel with my delegated authority.

- b. All personnel shall reduce air emissions from vehicles, including privately owned and operated. Therefore, no vehicle shall idle longer than 30 seconds, except for the time needed to defrost windows. When fueling vehicles, do not "top off" as this increases the risk of spills and contributes to air pollutants.
- c. Spills and leaks that pose a threat to human health and safety shall be reported to 911, otherwise spills and leaks shall be reported to the Installation Operations Center (IOC) at (804) 734-1584 immediately to meet the regulatory 24 hour deadline. Illicit non-stormwater discharges and dumping into storm drains are prohibited. The Fort Lee Spill Response Poster and Report Form are enclosed for your reference and shall be posted and reviewed on job sites and in government owned and operated vehicles.
- d. Fort Lee prohibits the feeding, capturing, releasing, or injuring of ANY wild animal on the installation. Assistance with wildlife should be directed to either the Game Warden (434-694-5012) or the Natural Resources Manager (804-734-5080).
- e. Negligence and failure to adhere to environmental regulations may result in both civil and criminal charges and fines for the responsible party or parties. In short, Fort Lee's Environmental Policy is:
 - G Generate less waste and pollution
 - R Reduce environmental impact
 - E Ensure compliance
 - E Evaluate new projects
 - N Notify 911 and IOC of spills

- 6. CROSS FUNCTIONAL TEAM members are responsible for assisting EMD with coordinating and facilitating MI-EMS implementation and environmental compliance. The Fort Lee Cross Functional Team is comprised of representatives from all Garrison Directorates, DoD tenants, and other agencies as necessary.

FORT LEE SPILL RESPONSE

IMPLEMENTED WHENEVER A SPILL OCCURS OR IS DISCOVERED. KEEP ALL CHEMICALS AND SPILLS FROM ENTERING STORM DRAINS, STREAMS, PONDS, & CRITICAL HABITAT. ONLY RAIN MAY ENTER THE STORM DRAIN. LAWS REQUIRE STATE AND NATIONAL RESPONSE NOTIFICATION WITHIN 24 HOURS OF A SPILL. PLEASE NOTIFY APPROPRIATE PEOPLE IMMEDIATELY, INCLUDING AFTER HOURS.

IN THE EVENT OF A SPILL ...

STEP 1 - IF MATERIAL SPILLED PRESENTS A POTENTIAL TO HARM HUMAN LIFE, EVACUATE THE AREA IMMEDIATELY.

CALL 911.

STEP 2 - STOP THE FLOW. SHUT OFF PUMPS AND VALVES

STEP 3 - SHUT OFF IGNITION SOURCES; MOTORS, ELECTRICAL POWER, ETC.

STEP 4 - CONTAIN SPILL WITH PROPER ABSORBENTS FROM SPILL KITS.

PROTECT STORM DRAIN BY COVERING DRAINS WITH FILTER SOCK

STEP 5 - NOTIFY INSTALLATION OPERATIONS CENTER, (804)734-1584

STEP 6 - SUBMIT SPILL REPORT WITH PHOTOS TO ENVIRONMENTAL MANAGEMENT DIVISION (EMD) FOR ALL SPILLS. SEND TO: craig.a.norris10.civ@mail.mil; diana.m.maimone.civ@mail.mil

Environmental Regulatory Reportable Spills:

- Any sheen, discoloration, odor, or hazardous substance in storm drains, ponds, streams, grassy areas
- 25 gallons or more of oil or fuel on concrete/asphalt
 Spills not requiring regulatory notification, must still be reported to EMD. All staining and spill residuals must be photographed, documented, and submitted to EMD.
