**OPERATION ORDER PW 23-01 (INSTALLATION DEPLOYMENT SUPPORT PLAN [IDSP])**

Time Zone Used Throughout Order. Local.

**1. SITUATION.**

a. General. IAW DA EXORD 140-17, U.S. Army Garrison, Hawaii (USAG-HI) is designated as a Power Projection Platform (PPP) and Mobilization Force Generation Installation (MFGI). The Installation Senior Commander (SC) and USAG-HI synchronize and integrate installation operations with deploying units, installation deployment support enablers, and external resources to facilitate rapid, efficient deployment processes on the installation. Active component and federalized reserve component units must maintain detailed unit deployment plans and train to meet established standards. USAG-HI must plan, resource, train for, and execute actions necessary to deploy and redeploy forces to meet the requirements of Combatant Commanders (CCDRs) stemming either from rotational and emergent force allocations, crisis action planning, or from approved contingency plans with or without mobilization.

b. Installation Senior Commander. IAW AR 525-93, Army Deployment and Redeployment, dated 23 Oct 19, the SC exercises Mission Command over all installation support operations. The SC has the authority to influence decision-making based on priorities and support capabilities of the installation. The SC provides unity of effort and unity of command.

c. Schofield Barracks (SB). SB is an active MFGI for COMPO 2/3 units providing integrated installation support services to include facilities, infrastructure and programs enabling commanders to mobilize, train, deploy and demobilize their units. SB is also a Power Projection Platform, supporting the Total Army to mobilize and generate the forces required, and project those forces anywhere in the world at any time.

d. Installation Deployment Support Plan (IDSP). Schofield Barracks, Hawaii (SBHI) provides the infrastructure, logistical and non-logistical services and processes that support deployment and redeployment operations. This IDSP defines the concept of installation support to ensure the delivery of trained, medically fit, and deployable units, Soldiers, and equipment. The IDSP provides an overview of all processes, policies, events and activities synchronized with the integration of personnel, resources and organizations for deployment / redeployment planning and execution.

e. Task Organization. See Annex A (Task Organization) for additional details.

(1) USARPAC. United States Army Pacific postures and prepares Army Forces, sustains and protects those forces in the theater, sets the theater, supports the development of an integrated multi-domain Joint force, and builds military relationships that strengthen Alliances and develop partner defense capacity in order to promote a free and open Indo-Pacific.

(2) AMC. The Army's primary logistics and sustainment command, responsible for

managing the global supply chain and ensuring installation and materiel readiness across the Total Force. AMC delivers logistics, sustainment and materiel readiness from the installation to the forward tactical edge to ensure globally dominant land force capabilities.

(3) Installation Management Command (IMCOM). IMCOM delivers quality base support from the Strategic Support Area, (SSA) enabling readiness for a globally responsive Army.

(4) 25<sup>th</sup> Infantry Division (25ID). 25ID conducts persistent engagement with regional partners to shape the environment and prevent conflict across the US INDOPACOM region. On order, 25ID deploys, fights and wins in large scale combat operations.

(5) 196<sup>th</sup> Infantry Training Brigade (196 IN BDE). The 196th IN BDE is the Indo-Pacific Training Support Brigade, delivering a unique low-density, high-payoff Total Army combat readiness capability at low-cost for USARPAC that is not replicated anywhere in the Army. 196<sup>th</sup> IN BDE remains relevant to the Total Army force and USARPAC when simultaneously delivering balanced and integrated training support across National Defense Authorization Act (NDAA) Title XI, Senior Army Advisor, Army National Guard (SRAAG), Joint Pacific Multinational Readiness Center (JPMRC), and Enhanced Home Station and Multinational training mission areas.

(6) 402th Army Field Support Brigade (AFSB). The AFSB is Army Sustainment Command's (ASC) lead national-level provider for support and is a key coordinator of related acquisition, logistics, and technology actions on the battlefield. The AFSB Commander executes deployment, equipment issue, equipment turn-in, and redeployment support operations.

(7) Army Field Support Battalion Hawaii (AFSBn-HAW). AFSBn-HAW provides installation logistics support as required using organic capabilities, serving as the SC's primary staff for key logistical and readiness support on the installation. AFSBn-HAW provides logistics support in the areas of Army Supply to include Classes I, II, IV, V, VII, and IX. AFSBn-HAW provides transportation to deployment nodes throughout the installation.

2. MISSION. USAG Hawaii synchronizes PPP/MFGI services IOT provide mobilization and demobilization support to deploying and redeploying forces in the USARPAC AOR IAW the Combatant Commander's OPLAN .

### 3. EXECUTION.

#### a. Commander's Intent.

(1) Purpose. Facilitate and integrate deployment / redeployment services and force protection measures IOT meet the latest arrival date (LAD) for specific deploying forces.

(2) Key Tasks.

(a) Exercise full Title 10 responsibilities (both mission and installation authorities) for tenant and attached units to include organizational training, unit readiness, leader development, validation and deployment of units.

(b) Facilitate coordination between support installations, the United States Army Reserve Command (USARC), and the National Guard Bureau (NGB) IOT provide installation and Soldier support facilities and services for mobilizing / demobilizing units and Soldiers to meet deployment timelines.

(c) Prioritize and coordinate the execution of mobilization operations and day-to-day base operations/life support missions with stakeholder units and organizations to ensure a common operating picture.

(d) Secure installation to prevent physical or cyber interference with mobilization operations.

(3) End State. USAG-HI is prepared and ready to support mobilization operations and provide uninterrupted installation support to deploying and redeploying units and Soldiers.

b. Concept of Operations. This operation consists of three interrelated phases to enable power projection in response to requirements for military operations. Garrison Installation Support Directorates (ISD) and Installation Support Offices (ISO) enable deployment and redeployment through implementation of each phase with seamless transitions and interactions. These phases may overlap or, at times, occur concurrently.

(1) Phase I (Prepare).

(a) The Prepare phase begins upon publication of this plan and ends when a validating command certifies the unit as ready to deploy. It includes measures taken to increase capacity, capability and preparedness for rapid expansion of mobilization / demobilization and deployment operations. This phase includes development and implementation of plans and procedures.

(b) During this phase, USAG-HI, ISDs, and ISOs assist deploying units with conducting pre-deployment activities to include identifying Soldier readiness requirements, supplies, training resources, and equipment necessary to accomplish USARPAC and CDR guidance. The Garrison will coordinate with the Mobilization Support Force (MSF) to update LOGCAP plans annually ICW Army Sustainment Command (ASC), conduct annual IDSP and Mobilization Support Plan (MSP) synchronization, Table Top Exercises (TTX) and support both Deployment Readiness Exercises (DRE) and Emergency Deployment Readiness Exercises (EDRE). Concurrently, ISDs and ISOs integrate units into their tracking processes and databases.

(2) Phase II (Deploy). This phase begins when a unit is alerted to deploy and ends when the unit arrives at the POE. This notification may be deliberate with Prepare to Deploy Orders (PTDO), or it may occur with little notice. During this phase, a deploying unit begins to

coordinate for the movement of equipment and personnel from SB to a Port of Embarkation (POE). ISDs, ISOs and tenant units synchronize the movement of deploying units and equipment ICW with AMC and Surface Deployment and Distribution Command (SDDC) according to Time Phased Force Deployment Data (TPFDD) with prioritization based on prescribed latest arrival date (LAD) as determined by CCDRs.

(3) Phase III (Redeploy, Demobilize and Reintegrate). This is a conditions-based phase that includes both Active and Reserve component forces and begins when the geographic CCDR issues a redeployment order releasing units from their mission and authorizing movement. RC forces return to their originating MFGI to demobilize with follow on movement to their home of record or home station to complete block leave and reintegration.

(a) Redeploy. Redeployment involves the return of personnel, equipment, and materiel to home and / or demobilization stations and considered as an operational movement critical in reestablishing force readiness. The unit begins the redeployment process by identifying requirements and determining current unit status. Other actions include submitting personnel actions, maintaining personnel accountability, conducting medical screening, performing equipment checks and services, conducting equipment inventories, and refining the unit deployment list. Once redeployment planning is complete, forces prepare personnel, equipment and materiel for movement to the POE. Unit movement officers coordinate for the arrival of the unit at the sea and aerial POE and the onward movement of equipment from the Port of Debarkation (POD) to home station. Units and ISDs / ISOs coordinate life support at SB and ensure they maintain security and accountability for sensitive items.

(b) Demobilize. Demobilization is a RC process with the primary function to complete reverse SRP including medical, dental, and mental health screenings. Additionally, Soldiers will account for equipment, turn in SB-issued Central Issue Facility equipment and complete finance and personnel actions. Upon completion of all demobilization tasks, the Soldier Readiness Processing Center (Building 555 aka "CONROY BOWL") of the Military Personnel Division (DHR) will process the REFRAD release of Soldiers allowing them to return to their home of record.

(c) Reintegrate. Upon return to home station / home of record, Soldiers and units of all components conduct Soldier-Family reintegration, block leave (if authorized) and unit reconstitution. This phase ends when directed by unit commanders as units transition back to Phase I (Prepare).

b. Scheme of Movement and Maneuver. ISDs and ISOs facilitate a unit's execution of tasks and movement IAW the notification (N-Hour) sequence of the 25ID Readiness Standard Operating Procedures (RSOP). See Appendix 3 (Consolidated Timeline) to Annex C (Operations).

c. Assessment. See Annex T (Training and Assessment).

d. Tasks Common to all Phases.

(1) Tasks to ISD / ISO and Partners in Excellence (PIE).

(a) Directorate of Plans, Training, Mobilization, and Security (DPTMS).

1. Prepare, maintain, and periodically exercise all or portions of this IDSP as directed by the Garrison Commander or Senior Commander.
2. Develop and execute an IDSP exercise program in coordination with unit Deployment Readiness Exercises (DRE) to synchronize activities across installation support functions and to correct deficiencies, vulnerabilities, and shortfalls identified during the evaluation process.
3. Oversee Emergency Operations Center (EOC) to provide integrated Command and Control capability to support operations and to provide unit commanders a Common Operating Picture.
4. Manage the current Support Base Services (SBS) contract to ensure quality of services provided by the contractor. This includes maintenance of Area X-ray.
5. Manage and coordinate RC mobilization IAW Annex F (Installation Mobilization Support Plan) to ensure RC units deploy within allotted timeframes in support of CCDR requirements.
6. Supervise the execution of the Force Protection program.
7. Manage mobilization and demobilization operations.
8. Review/revise this plan annually.

(b) Directorate of Public Works (DPW). Improve, modernize, and maintain proactive restoration maintenance programs at all operational deployment nodes to ensure infrastructure is modernized and capable to support uninterrupted deployment and redeployment operations.

(c) Directorate of Emergency Services (DES).

1. ICW DPTMS Protection Division, execute all tasks listed in Annex D (Protection) to provide a safe and secure environment for the military, civilians, and families that make up the SB community.
2. Support mobilizing forces IAW Annex F (Installation Mobilization Support Plan) to ensure freedom of movement and enhanced security.

(d) Directorate of Human Resources (DHR). Resource SRP site(s) to support units with SRP Level 1 and 2 as well as post deployment readiness. Maintain a list of personnel service support to the 25ID RSOP.

(e) Public Affairs Office (PAO).

1. Coordinate and disseminate command information IAW Annex H (Public Affairs) to this plan.
2. Provide media support and guidance to directorates and agencies as needed.

(f) Directorate of Family and Morale, Welfare and Recreation (DFMWR).

1. Provide Installation-level 2 to Soldier / Family / Civilian support programs that quickly provide a resilient support network for deploying Soldiers and their families.
2. O / O activate the Emergency Family Assistance Center to connect Soldiers and family members with services at the time of need.
3. O / O provide regulatory pre-deployment briefings, Casualty Response (CARE) Team Training, Reintegration Training (RIT), Family Readiness Group (FRG) training, Soldiers Family Readiness Representative (CFRR) and Family Readiness Support Assistants (FRSA) training.

(g) Network Enterprise Center (NEC). See Annex G (Signal).

(h) Desmond T. Doss Health Clinic (DDHC). Conduct SRP operations to include specialty referrals and consultations. Provide medical support as requested IAW HQDA regulations and directives.

(i) AFSBn-Hawaii. Conduct deployment and redeployment support to SB units IAW Annex E, Sustainment.

e. Coordinating Instructions.

(1) Coordinate requests for information to USAG-HI or other supporting organizations through DPTMS. When information requests are directed to other ISDs and ISOs, provide DPTMS Plans and Operations copies for tracking purposes.

(2) All ISDs, ISOs, and PIEs (Partners In Excellence) will attend and participate in an annual exercise IOT validate this plan.

(3) Time – Phased Force Deployment Data (TPFDD) with prioritization based on prescribed latest arrival date (LAD) as determined by CCDRs will determine priority of support and movement.

(4) Timeline. USAG-HI will support deployment and redeployment operations IAW the deploying unit's notification hour (N-Hour) sequence and Readiness Standing Operating Procedures (RSOP). See Appendix 3 (Consolidated Timeline) to Annex C (Operations).

4. SUSTAINMENT. See Annex E (Sustainment).

5. COMMAND AND SIGNAL.

a. Command. The Senior Commander (SC) exercises Mission Command over all installation support operations. The SC has the authority to influence decision-making based on priorities. The 25ID Lightning Operations Center (LOC) provides the ability to exercise Mission Command with a command and control platform capable of operating 24/7/365 in support of the SC's mission of providing trained and ready forces to USARPAC.

(1) Location of Commander and Key Leaders.

(a) The 25ID G3 will activate the 25ID LOC, building 580, SBHI, for 24/7/365 operations in support of the SC's mission of providing trained and ready forces to USARPAC.

(b) The USAG-HI Commander is located at Building 107, WAAF.

(2) Succession of Command.

(a) Senior Commander (SC)

(b) Deputy Commanding General - Operations (DCG-O)

(c) Deputy Commanding General - Support (DCG-S)

(d) 25ID Chief of Staff (COS)

(e) USAG-HI Garrison Commander (GC)

b. Control. Command Posts

(1) Lightning Operations Center (LOC). The LOC is the focal point for 25ID Mission Command during mobilization and deployment. It supports Division and Garrison combined operations to meet the SC's Mission Command requirements. The LOC is located in the SB, 25ID, Headquarters, Building 580, SBHI. The LOC collects Mission Data from the USARPAC Deployment Cell / Tactical Air Command Cell (TAC-C), maintains awareness of current TPFDD, and connects to the Global Decision Support System (GDSS II) and the Global Transportation Network (GTN).


