////UPDATED INFORMATION////

- Health Protection Condition (HPCON) has upgraded to Level C
- There are 151 cases confirmed in Hawaii
- > Army COVID-19 information Hotline (800) 984-8523
- Hawaii COVID Medical Hotline: (888) 683-2778; option 8; available Mon-Fri 6:30 a.m. 4 p.m and Saturdays 7 a.m. 4 p.m.

PCS, TDY, and Leave Travel:

- > Soldiers that have already started their PCS to a CONUS station by clearing U.S. Army Hawaii and departing the island of Oahu will continue their movement to the next duty station.
- Soldiers affected by stop movement order can call the U.S. Army 24-hour Service Center's travel information office number is 1-800-582-5552, and choose option 5, for guidance. All other PCS and TDY travel is postponed until at least May 11th, exceptions can be granted for (1) mission essential; (2) humanitarian reasons; or (3) extreme hardship.
- > Local leave is authorized for Soldiers, family members and DA Civilians, NO Inter-island travel.
- > Anyone arriving on island will be placed on Restriction of Movement for 14 days.
- > Units away for training (such as Pacific Pathways) are scheduled to continue training and return as previously expected.
- > Courses at the Lightning Academy have been canceled until further notice.

Increased Health Protection Condition (HPCON) Measures:

- > Individuals that feel they have symptoms should call the TRICARE nurse line at 1-800-874-2273, and follow directions given.
- > Soldiers encouraged to conduct physical training on their own during stay-at-home order.
- > No long-term visitor passes will be issued at the VCC at Leilehua. Retirees have access with retiree ID card still.
- > TAMC: No Visitors: Exemptions:
 - Inpatient: One attendant per day for children under 18, Maternity and patients facing end of life.
 - Outpatient: One attendant for children under 18 and patients with cognitive or physical.
- Gate entry procedures include "no touch" on CAC cards.

Facility and Service Closures or Reduction:

- All public schools are closed through April 30th.
- CYS Facilities are closing Mar 27. On Mon, Mar 30, one CDC will be open for Mission Essential Personnel in the north and one in south. More information to follow. School age centers also open in the north and south.

- Commissary Hours:
 - □ Elderly Shopping: Tue/Wed/Fri: 9 10 a.m.
 - □ All Patrons: Mon/Thur: 11 a.m. 8 p.m.; Tue/Wed/Fri: 10 a.m. 8 p.m.; Sat/Sun: 9 a.m. 8 p.m.
- Gate Closures: AMR: Back Gate; Fort Shafter: Patch Gate; Schofield Barracks: Foote Gate and Macomb Gate; Wheeler Army Airfield: Kawamura Gate.
- > All Gyms are closed
- > Bowling Alley and Tropics are now closed (previously take-out only).
- > YMCA Children's waiting rooms at TAMC and DDHC are temporarily closed.
- Commissary is no longer allowing reusable bags.

Work from home order:

On 22 March 2020, the Honolulu Mayor issued a local shelter in place order, effective 4:30 p.m. on 23 March 2020 to 4:30 p.m. on 30 April 2020. On the 23 March 2020, the Hawaii Governor issued a statewide shelter in place proclamation, effective

0001 on 25 March 2020 to 11:59 p.m. on 30 April 2020. Violation of the Honolulu Order or HI Proclamation is punishable by misdemeanor - \$5,000 fine and/or one year in jail.

Soldiers (SM's) and Department of the Army Civilians (DAC) can travel from off-post residences to on-post facilities:

- Both the Order and Proclamation allow travel for SMs and DACs to and from their residence for the purposes of work required activities.
- SMs and DACs, when off-post and off-duty, as well as Family Members must follow the Order and Proclamation:
- May leave residences to go to certain establishments needed for living, such as grocery stores, convenience stores, restaurants (takeout/delivery only), healthcare facilities, gas stations, banks. This includes driving to U.S. Army Hawaii Installations to go to the commissary, restaurants, and PX for necessary purchases.
- · May engage in outdoor activities (maintaining social distancing) such as walking, hiking, running, ocean swimming and surfing.
- May leave residences for tasks for health and safety of family and pets, obtain necessary services and supplies, and to care for family/pets in another household—travel to locations to participate in these activities is authorized.
