SUBJECT: United States Army Hawaii (USARHAW) Policy Letter # 15 – U.S. Army Hawaii Replacement Company In-processing Procedures

1. References:

a. Army Regulation 600-8-101 Personnel Readiness Processing, 06 March 2018.

2. Applicability. This policy applies to all incoming Soldiers and Department of the Army Civilians assigned or attached to tenant units of USARHAW.

3. Intent. A Permanent Change of Station (PCS) to Hawaii is one of the more challenging moves a Soldier and Family will experience in their service. Commanders at all levels will welcome our new teammates and their Families and provide them with the resources and leadership necessary to make their PCS as smooth as possible. A Soldier's experience during their in-processing—whether returning to Hawaii after previously serving here or arriving for the first time—is critical to setting the tone for their entire assignment. Good units take special care to welcome new Soldiers and their Families, and the USARHAW Replacement Company is charged with doing just that. Without a doubt, the Replacement Company is the most important company in USARHAW and as the Senior Commander, I have resourced them to provide the essential support that Soldiers and their Families need during their first weeks in Hawaii.

4. Policy. This policy establishes the procedures and requirements for newcomers reporting to Hawaii-based units using the USARHAW Replacement Company. This policy reflects a standard week of in-processing. Due to federal holidays and Days of No

Scheduled Activities (DONSA), the days of each event may change, but the requirements remain the same. In-processing activities are mandatory and will not be superseded without approval of the Chief of Staff, 25 ID and USARHAW.

5. Reporting Procedures:

a. All incoming Soldiers will sign in with the USARHAW Replacement Company. Soldiers may report in duty uniform or civilian attire. The uniform throughout inprocessing is the Operational Camouflage Pattern (OCP) uniform unless told otherwise. Soldiers may use any of the three locations in sub-paragraphs (1) through (3) to report to the USARHAW Replacement Company.

(1) USARHAW Airport Liaison Desk – Located at the Daniel K. Inouye International Airport Terminal in Baggage Claim 19; operational hours are 1100-2300 daily. Their phone number is: (808) 859-5784.

(2) USARHAW Replacement Company Headquarters – Located at Soldier Support Center, Building 750, Room 102 on Schofield Barracks; operational hours are 0900-1600 from Monday-Friday, except federal holidays. Their phone number is: (808) 655-4634.

(3) USARHAW Replacement Company Barracks Reception Desk – Located at Building 1020 on Schofield Barracks; operational 24 hours, 7 days/week. Their phone number is: (808) 655-0389.

b. All incoming Soldiers are encouraged to go to Baggage Claim 19 at the Daniel K. Inouye International Airport Terminal upon their arrival to receive additional information about in-processing and reporting procedures.

c. All Soldiers arriving to Oahu are able to report under the following conditions:

(1) Soldiers who arrive on or before their report date, and sign in will begin inprocessing immediately. Basic Housing Allowance (BAH), Cost of Living Allowance (COLA), and Temporary Housing Allowance (TLA) are authorized effective the date they sign in. Entitlements will be processed following the Soldier's meeting with finance, conducted on day 1 and day 2 of in-processing.

(2) Soldiers arriving on island prior to their report date who wish to take additional leave or administrative absence (previously PTDY) may sign in off of PCS leave and sign back out on ordinary leave or administrative absence. Soldiers are encouraged to submit their leave form prior to arriving by emailing usarmy.schofield.25-id.list.usarhaw-repl-co-s1@army.mil. Alternatively, they can submit their leave form in-person at any of the three in-processing locations. Soldiers electing to execute this option will receive back pay (BAH and COLA) from the day they sign in, after completing their finance paperwork on day 1 or 2 of in-processing. TLA is not authorized while on leave.

(3) As permissible at any duty station, Soldiers who arrive on island with preauthorized ordinary leave or administrative absence (previously PTDY) may take their leave and then sign in at the end of their leave period. Soldier's electing this option will not receive Hawaii BAH, COLA, or TLA until they sign in off of leave.

6. Program of Instruction:

a. Soldiers will be placed in three groups at the start of in-processing – Junior, Mid, and Senior. Juniors are Private through Sergeant, Mid are Staff Sergeant through Master Sergeant, Second Lieutenant through Major, and Warrant Officer One through Chief Warrant Officer Three. Seniors are Lieutenant Colonel and higher, Chief Warrant Officer Four and Five, Sergeant Major and Command Sergeant Major.

b. In-processing will begin on the first duty day of the week. In a standard week, inprocessing begins on Monday and is a 4-day process. All personnel are required to report at 0845 hours to the Replacement Company – Located at Building 750, Room 102 on Schofield Barracks, to in-process.

c. Soldiers in the Junior and Mid categories must follow the program of instruction listed in Enclosure 1 and 2. The only mandated events for the Senior group are Finance, the Division Patching Ceremony (Day 1), Newcomer's Physical Training (Day 2) and Medical (Day 3).

d. Finance In-Processing: All Soldiers will report to Building 750 at 0900 for the finance in-processing on Day 1. The following are required to in-process finance:

(1) MyPay username and password (created at https://mypay.dfas.mil/#/).

(2) PCS orders with amendments.

(3) DA Form 31 (Leave Form with blocks #14 and #16 signed) bringing the Soldier to Hawaii and any additional DA31's that may have been issued after arrival but before in-processing.

(4) POV inspection/shipping form, marriage certificate, and birth certificates for dependent children (as applicable).

(5) Flight itinerary.

e. Community Readiness Expo (CRE). The USARHAW Community Readiness Expo is an interactive orientation that is offered weekly on Thursdays 0845-1200 at the 604 Conference Room, 1249 Kolekole Ave, Schofield Barracks, HI. Soldiers and Families attend the event to learn about Army community resources from service agency representatives.

f. During in-processing, all Soldiers are required to review their DD Form 93 (Emergency Notification Data) and service member's group life Insurance (SGLI) to ensure all information is current. Soldiers will be provided a copy of these documents upon completion.

7. Requests for exceptions to this policy must be submitted in writing to the U.S. Army Replacement Company Commander for consideration by the Chief of Staff, 25 ID and USARHAW.
