MEMORANDUM FOR RECORD

SUBJECT: 25th Infantry Division and U.S. Army Hawaii Policy Letter #14 – Authorization to Roll Sleeves on the Operational Camouflage Pattern (OCP)

1. References:

- a. Army Regulation (AR) 670-1, Wear and Appearance of Army Uniforms and Insignia, dated 10 April 2015.
- b. Department of the Army Pamphlet (DA PAM) 670-1, Guide to Wear and Appearance of Army Uniforms and Insignia, dated 1 July 2015.
- c. Memorandum, Department of the Army, Office of the Deputy Chief of Staff, G-1, 27 September 2016, Subject: Authorization to roll sleeves on the Army Combat Uniform (ACU).

2. Purpose. To outline the policy for rolling sleeves year-round while wearing the universal camouflage pattern (UCP) ACU, operational camouflage pattern (OCP) ACU, and Operation Enduring Freedom camouflage pattern (OEF-CP) ACU. The sleeves on the Army Aircrew Combat Uniform will not be rolled under any circumstances. Wear and appearance of all other uniforms remains in accordance with standards outlined in AR 670-1 and DA PAM 670-1.

3. Applicability. This policy applies to all Soldiers assigned to the 25th Infantry Division and all other U.S. Army Hawaii (USARHAW) units.

4. Company level commanders may authorize Soldiers to roll sleeves on the UCP ACU, OCP ACU, or OEF-CP ACU coats. When authorizing rolled sleeves, company level commanders will determine if the unit will roll sleeves with the camouflage pattern exposed or turned inside out. In either configuration, the following apply:

- a. Personnel will roll sleeves neatly above the elbow by not more than three inches above the elbow.
- b. Rolled sleeves are only authorized in a garrison environment.

5. Soldiers will not roll their sleeves (sleeves must be down) during the following conditions:
  - a. While conducting range operations.
  - b. While wearing tactical gear.
  - c. Motorcyclists must cover their arms while riding, be either rolling sleeves down or wearing an approved jacket.
  - d. While operating or a passenger in a military tactical vehicle.
  - e. While a passenger in a military aircraft.
  - f. While participating in formal events, such as Flying "V", change of command, or change of responsibility ceremonies.
6. Soldiers who are unable to roll their sleeves due to the size of the cuff are authorized to wear sleeves down at all time with company commander approval.
7. During field training exercises or in a deployed environment, company level commander may authorize Soldiers to cuff the coat sleeves one or two times. The coat sleeve may be cuffed inside or outside the coat.
8. During a battalion, brigade, or higher formation, the most senior commander will prescribe the uniform for wear. Mixing of rolled sleeves and unrolled sleeves while standing in any formation is not authorized.
9. This memorandum supersedes USARHAW Policy Letter #19, dated 4 August 2016 and remains in effect until superseded or rescinded in writing.
