Request to install crosswalk on the west side of Trimble and Cadet Sheridan intersection.

The project requires a design that would consists of the following: Upgrade the existing traffic signal with pedestrian mounted signals to notify pedestrians when it is safe to cross.







Private Organizations Purpose

- The Department of Defense (DoD) recognizes that events and support provided by nonprofit non-federal entities (private organizations) that assist Service members and Families can be important to their welfare throughout their military service.
- It is in the DoDs best interest to maintain strong and positive relationships, as appropriate within the bounds of the law and regulation, to facilitate delivery of services, through private organizations.
- The nature of services, the needs of the installation, and the needs of Service members and their Families are considered when determining whether a private organization is permitted to function on the installation.
- This briefing summarizes the policies and regulations that establish the guidelines for private organizations operating on the installation.

Private Organizations Oversight and Administration

- The Senior Commander has authority over installation access and approval to operate for all non-Federal entities (private organizations).
- Before operating on Department of Defense (DoD) installations, private organizations must request and receive written permission.
 - Garrison Commander Designated authority for approval, disapproval, and withdrawals.
 - Directorate of Family and Morale, Welfare and Recreation Designated to manage the administrative process for private organizations.
- Responsibility for command oversight of the program includes regulatory requirements to:
 - Be aware of all private organizations operating on DoD installations.
 - Review membership provisions.
 - Implement and ensure compliance with regulatory requirements.
 - Ensure that programs do not compete with Army and Air Force Exchange Service (AAFES) or Family and Morale, Welfare, and Recreation (MWR) activities.
 - Take action as necessary to ensure compliance / withdraw authorization.



Private Organizations General Guidelines

- Private Organizations shall be self-sustaining, primarily through dues, contributions, service charges, fees, or special assessment of members. The sole purpose of a private organization cannot be to raise funds.
- Private organizations are not entitled to certain levels of DoD support unless they have statutory authorization (Example: American National Red Cross, United Service Organization, Armed Service YMCA, Civil Air Patrol).
- DoD personnel acting in an official capacity will not execute charters that serve as the legal basis for any non-Federal entity or other private organization.
- The private organization entity shall have adequate insurance to protect against liability and property damage claims or other legal actions.
- Private organizations shall comply with applicable fire and safety regulations. They are not exempt from State or local laws because they operate on Federal property. They must obtain any required licensing, certification, or registration required by State and local authorities
- Private organizations must receive permission to conduct events that are on the installation and are open/advertised to more than their immediate members.



Private Organizations General Guidelines

- Installations cannot favor or appear to favor one Private Organization over another. Private
 Organizations will receive no special treatment or Army endorsement even if they promote Army
 goals or support the military community.
- To prevent the appearance of official sanction or support by the Department of Defense: Non-Federal entities may not use the seals, logos, or insignia of the Department of Defense or any DoD Component, DoD organizational unit, or DoD installation on organization letterhead, correspondence, titles, or in association with organization programs, locations, or activities.
- Private Organizations are not part of the military, so they will receive only limited Government supervision and oversight.
 - Private Organizations cannot use Army services or official resources (legal, audit, transportation, postal, printing, management, etc.)
 - DoD personnel are not authorized to participate in day-to-day management for a Private Organization not authorized to act as a fiduciary.
- The Staff Judge Advocate Office will review all private organizations requests for legal sufficiency.





Private Organizations Common Requests - Special Requirements

•Ongoing Compliance and Reporting Requirements

• Report major changes in: activities, membership requirements, officers, objectives, organization, structure, management functions, constitution and bylaws, planned use of funds must be reported to remain in good standing.

- Submit reoccurring reporting / documentation requirements (see slide 8).
- Comply with applicable regulations and policies.
- •Fundraising
 - POs must receive permission to conduct fundraisers
 - Fundraising is only authorized on an occasional basis. They must not compete with the Combined Federal Campaign or Army Emergency Relief.
 - The Department of Defense (DoD) cannot co-sponsor, endorse or appear to endorse PO fundraisers, except allowed by other regulations (Combined Federal Campaign, Army Emergency Relief)
 - Fundraisers cannot duplicate and / or compete with Army / nonappropriated fund programs
 - Legal review is required
- Advertising
 - POs may utilize paid advertising available through the Directorate of Family and MWR
 - All advertising present on the installation to more than it's immediate members must be approved
 - All print material must contain a disclaimer
- Membership Drives
 - POs must receive permission to conduct memberships drives that are on the installation and advertised to more than their immediate members
 - DoD cannot co-sponsor, endorse, or appear to endorse PO membership drives

Department of the Army Regulation

Joint Ethics Regulation – Case Samples

The Fort Green Chief of Staff, a member of the local chess club, calls MWR and asks that the chess club's application to hold a fundraising event on the installation be moved to the top of the pile.	Use of public office for personal/private gain, conflict of interest; acting as an agent for a private organization before the Federal government. 18 USC 205 and JER para 3-204.		
The Commander of XXX Corps allows his duty position to be used on the letterhead of the Humane Society of the United States.	Improper endorsement. 5 CFR 2635.702; JER 3-205.		
Colonel Johnson is the treasurer of the local chapter of the Military Intelligence Association of America (MIAA) and is responsible for MIAA's monthly billing statements for dues. He tasks his secretary to prepare the billing statements during duty hours on government equipment.	Misuse of government resources and time. 5 CFR 2635.704 and 705; JER para 3-305b.		
A unit commander appoints a unit point of contact for the local Military Spouses Organization (MSO) membership drive.	Misuse of position, misuse of government resources, endorsement of a private organization, official participation in membership drive. 5 CFR 2635.702 and .705I; JER para 3-205 and 3-210.		
Captain Blue, Commander, A Company, is a member of the National Association of Officers (NAO). He directs his soldiers to accept donations (i.e., sell) raffle tickets for the NAO's major fundraising event during duty hours while in a duty status.	Misuse of position and government resources. 5 CFR 2635.702 and .705; JER para 3-305. May also be in violation of State law concerning gambling and lotteries.		



Private Organizations Membership Drives

Joint Ethics Regulation (JER) DoD 5500.7-R – Membership Drives

- Private organizations must receive permission to conduct membership drives that are on the installation and advertised to more than immediate members.
- Department of Defense (DoD) employees may become members and may participate in the management of non-Federal entities as individuals in a personal capacity provided they act exclusively outside the scope of their official position.
- DoD cannot co-sponsor, endorse, or appear to endorse private organization membership drives or fundraising for any non-Federal entity except the following organizations which are not subject to the provisions of section of this regulation, below:
 - The Combined Federal Campaign
 - Emergency and disaster appeals approved by the Office of Personnel Management
 - Army Emergency Relief
 - Navy-Marine corps Relief Society;
 - Air Force assistance Fund



Private Organizations Installation Fundraising

AR 600-29, Fund-Raising within the Department of the Army, 7 Jun 2010

- Private organizations must receive permission to conduct fundraisers.
- There is no right to fundraise on Army installations and fundraising activates will only be authorized on an occasional basis in accordance with this policy memorandum.
- Department of Defense cannot co-sponsor, endorse or appear to endorse private organization fundraisers.
- Fundraisers must not conflict with authorized annual Combined Federal Campaign or Army Emergency Relief.
- Sales of items cannot duplicate services provided by the MWR program or AAFES, or otherwise compete with MWR or AAFES, unless they first obtain explicit written approval from DFMWR or AAFES.



Private Organizations Installation Fundraising

United State Army Hawaii Regulation 1, Standards and Discipline, 20 June 2017

- Fundraising activities on the installation require prior written approval of the U.S. Army Garrison Hawaii, Directorate of Family and Morale, Welfare and Recreation.
- Fundraising events must observe the principle of true, voluntary giving. Commanders, supervisors, or individuals in the supervisory chain should never solicit their employees or subordinates.
- Door-to-door fundraising at Island Palm Communities quarters is prohibited.
- Fundraising is prohibited in offices and work areas on the installations.
- While fundraising, Soldiers must be off-duty, volunteers, and not in uniform (including the Army Physical Fitness Uniform).



Private Organizations Installation Fundraising

Policy Memorandum USAG-HI-18, Fundraising on USAG-HI Installations, 15 October 2018

- The Garrison Commander has designated, The Directorate of Family and Morale, Welfare and Recreation (DFMWR) as directorate responsible fundraising on Hawaii Army installations.
- The Business and Nonprofit Liaison (DFMWR) will coordinate requests to conduct business on the installation with established installation programs for concurrence (ex: Army Air Force Exchange or DFMWR) and validates concurrence with Island Palm Communities and Staff Judge Advocates.
- All fundraisers to be held at AAFES, the Fort Shafter market and the Paradise Express facility must be coordinated with the Service Business Manager of Hawaii Exchanges at (808) 423-7302 prior to submitting a request packet to DFMWR for approval.
- All fundraisers to be held at the Schofield Barracks Commissary must be coordinated with DeCA Store Manager at (808) 655-5066 ext. 202 prior to submitting a request packet to DFMWR for approval.



Department of the Army Regulation Advertising

AR 215-1, Military Morale, Welfare and Recreation Programs and Nonappropriated Fund Instrumentalities, 24 Sep 2010

- Morale, Welfare and Recreation programs may sell space for commercial advertising (printed, signs, electronic) produced for or prepared by them and may accept payment for such advertising.
- The local garrison commander will make final decisions on acceptance of advertising.
- All commercial advertising agreements must be in writing and must receive legal review prior to entering into the agreement and prior to signature of the parties.
- Advertising will not contain anything in it that might be illegal or contrary to Department of Defense or Army regulations.
- No advertising will be accepted from any establishment placed "off limits" by the commander.

United State Army Hawaii Regulation 1, Standards and Discipline, 20 June 2017

POSTING OR DISPLAY OF ADVERTISEMENTS: Permission from the Garrison Commander is required for posting or displaying advertisements or banners.
