Soldiers who are being reassigned overseas must be medically and dentally qualified for assignment.
- C. Request to leave your Family at the present duty station until you complete your TDY. Once TDY is complete your Family Member(s) will join the Soldier at the new Permanent Duty Station. If the Soldier elects this option, a BAH/COLA Waiver Packet must be completed and submitted to HQDA for approval. (If Soldier elects to return to Hawaii, Soldier will pay out of pocket for the round trip airfare!)

IAW AR 600-8-10 Chapter 4-8: if COT leave travel is deferred, the Soldier must travel directly from the old PDS to the new PDS. No leave or other absence may be authorized enroute except for 4 days to drop off and/or pick up dependents if they are residing at an approved designated location.

If the PCS requires either the Soldier or Family members to traverse through CONUS, COT leave must be used between the two tours of duty. The only exception is if no chargeable leave is used enroute, and COT leave deferment is justified in writing as a military necessity by the losing or gaining commander.

A losing or gaining commander may authorize a deferment for military necessity, and Soldiers may request deferment of COT leave for personal reasons. The authorization and the reason for the deferment must be stated in the Soldier's PCS Orders and in item 11 on the Absent Request, additionally, the leave request must be disapproved IAW AR 600-8-10 Chapter 4-8 (o)
