- I will not excavate before receiving written approval on this form and I will only excavate at the locations requested on this form. I am responsible for damages caused to persons or property as a result of my fault or negligence.
- For construction projects, I will not excavate before receiving written approval on the DPW OMD Line Marking Form. For military training, I will obtain and observe the no dig overlay for my requested area.
- Unless otherwise permitted, I will not excavate within 50 meters of streams, natural drains, roads, or tank trails. I will not excavate, or deposit excavated soil, within 10 meters of trees or gully plugs.
- If archaeological resources (arrowheads, charcoal, bones, etc.) are discovered during excavation, I or my representative will notify DPW Cultural Resources at 254-287-1092 and suspend all excavation activities pending further guidance from DPW Cultural Resources.
- I will restore the excavation site including backfilling and reshaping to conform to surrounding topography. Construction sites will also be seeded and/or stabilized, as required.
- I will properly mark all unfilled locations and/or post guards until backfilled.
