MEMORANDUM FOR All Personnel, Fort Huachuca, Arizona (FHAZ)

SUBJECT: Policy 25-55, Child Supervision Requirements

1. **REFERENCE.** Army Regulation (AR) 600-20 (Army Command Policy), 6 Feb 2025.
2. **PURPOSE.** To establish supervision requirements for children on FHAZ in settings other than Child and Youth Services (CYS) and schools. This policy is grounded in the Senior Commander's mission to care for service members, families, and DA Civilians, and to enable unit readiness.
3. **APPLICABILITY.** This policy applies to all individuals who live or work on FHAZ or use FHAZ facilities.
4. **POLICY.**
 - a. Parents, guardians, and sponsors are solely responsible for providing supervision appropriate to the individual needs of children under their care. This responsibility includes providing supervision beyond minimum requirements due to medical, behavioral, or developmental needs. Installation agencies are not liable for accidents, injuries, or other incidents that arise from inadequate supervision in non-CYS and non-school settings.
 - b. The enclosed FHAZ Child Supervision and Curfew Matrix establishes minimum requirements for child supervision on FHAZ.
 - c. Any member of the Fort Huachuca community who observes or suspects a violation of this policy will report the incident to the Fort Huachuca Military Police at (520) 533-3000.
5. The FHAZ CYS and Family Advocacy Program (FAP) are available to assist parents, guardians, and sponsors in determining appropriate levels of supervision for the children under their care. They can be reached at (520) 533-0710 (CYS) and (520) 533-2437 (FAP).
6. This memorandum supersedes USAG Policy 24-55 (Fort Huachuca Supervision of Minor Children), 30 July 2024.
7. **PROPONENT.** The Point of contact for this policy is the Director of Emergency Services at (520) 533-3232.

This responsibility includes providing supervision beyond minimum requirements due to medical, behavioral, or developmental needs. Installation agencies are not liable for accidents, injuries, or other incidents that arise from inadequate supervision in non-CYS and non-school settings. All applicable CYS regulations remain in effect.
