SUBJECT: Command Policy #26, Standards of Reporting for Actual/Suspected Incidents of Child, Spouse or Intimate Partner Abuse; Child Neglect; and Problematic Sexual Behavior by Children and Youth

1. References:

2. Applicability. This policy applies to all military personnel, appropriated and non-appropriated civilian employees of the Department of Defense, contractor employees, and family member dependents (including spouses and children) that reside on USAG Humphreys or in Area III.

3. Policy.

- a. AR 608-18, the Army Family Advocacy Program (FAP), contains the Army policies for the FAP. FAP policy is designed to prevent child, spouse, and intimate partner abuse through a program of public awareness and early intervention, to protect victims of abuse from future violence, and to treat affected Soldiers and Family members.
- b. The Commander, USAG Humphreys, has primary responsibility for coordinating the overall FAP within Area III, providing prevention programs and training, and establishing reporting channels for abuse cases.
- c. All commanders are expected to cooperate with responsible Army officials in Family violence cases by promptly reporting known or suspected incidents of maltreatment, referring Soldiers for evaluation, and ensuring Soldiers are in compliance with established treatment plans.

SUBJECT: Command Policy #26, Standards of Reporting for Actual/Suspected Incidents of Child, Spouse or Intimate Partner Abuse; Child Neglect; and Problematic Sexual Behavior by Children and Youth

d. Both military personnel, adult dependents, civilian employees, contractor employees and members of the community are expected to report actual or suspected incidents of Family violence and problematic sexual behavior in children and youth that occur on or off the installation to the Military Police at DSN 315-755-9917 or commercial 0503-355-9917 (24 hours). Incidents occurring off post may also be concurrently reported to the civilian law enforcement authorities.

e. The Military Police will immediately notify FAP Clinical at DSN 315-737-3799 or commercial 0503-337-3799 (24 hours) and Army Community Service FAP/Victim Advocacy at DSN on post dial 153 or commercial/cell 0503-364-5997 (hotline) (24 hours) of all suspected incidents of actual or suspected Family violence and problematic sexual behavior in children and youth regardless of whether law enforcement initiates an investigation regarding the reported incident or not.

4. Proponent. The proponent for this policy is the Directorate of Family and Morale, Welfare and Recreation. All concerns or questions should be directed to Army Community Service FAP/Victim Advocacy.
