SUBJECT: Command Policy #45, Use of Smoke/Vapor Producing Devices

1. Reference AR 600-63, Army Health Promotion, 14 April 2015.
2. Purpose. To provide guidance regarding the use of smoke/vapor producing devices (including, but not limited to, cigarettes, electronic cigarettes, cigars, and open flame candles) in buildings located on USAG Humphreys.
3. Applicability. This policy applies to all military personnel, appropriated fund and non-appropriated fund civilian employees, contractor employees, family members, retirees, and visitors in USAG Humphreys facilities.
4. Punitive Action. For military personnel, this policy is punitive in nature. Failure to comply may constitute a violation of Article 92 of the Uniform Code of Military Justice (UCMJ). Violations may result in adverse administrative action or non-judicial or judicial punishment. For all others, failure to comply may result in administrative or disciplinary action.
5. Policy.
 - a. Use of smoke/vapor producing devices (including, but not limited to, cigarettes, electronic cigarettes, cigars, and open flame candles) is prohibited in the following locations on USAG Humphreys: All workplaces, all Family and Morale, Welfare and Recreation (FMWR) facilities, all Child and Youth Services (CYS) facilities and sports fields. Such devices may be used in designated smoking areas. If possible, designated outdoor smoking areas will provide a reasonable measure of protection from the elements. Designated areas will be at least 50 feet from common points of entry/exit, will not be located in areas that are commonly used by nonsmokers, and will be out of the presence or view of children.
 - b. Use of smoke/vapor producing devices (including, but not limited to, cigarettes, electronic cigarettes, cigars, and open flame candles) is prohibited in all military vehicles and aircraft, and in all official vans and buses.
 - c. Use of smoke/vapor producing devices (including, but not limited to, cigarettes, electronic cigarettes, cigars, and open flame candles) is not permitted in common spaces, assigned living quarters, or any other area (including, but not limited to,

corridors, laundry rooms, lounges, stairways, elevators, lobbies, storage areas, and restrooms) of multiple housing areas such as Family housing apartments, unaccompanied personnel housing (whether temporary or permanent), Army Lodging, and other Army-operated hotels and recreational lodging. Such devices may be used in designated smoking areas.

d. Use of smoke/vapor producing devices (including, but not limited to, cigarettes, electronic cigarettes, cigars, and open flame candles) by students is prohibited on the grounds of the Department of Defense Education Activity (DoDEA) schools, except as provided for by the Director, DoDEA. Visiting adults, faculty, and staff may use such devices out of the presence or view of students in areas designated by the Director, DoDEA.

e. Use of smoke/vapor producing devices (including, but not limited to, cigarettes, electronic cigarettes, cigars, and open flame candles) is prohibited where it presents a safety hazard, such as at firing ranges, ammunition storage areas, fuel dumps, motor pools, and equipment maintenance shops.
