SUBJECT: Command Policy #54, Patron Use of Family and Morale, Welfare and Recreation Fitness Centers and Indoor Pools

Purpose: To establish eligibility, priority, and sign in procedures for use of Family and Morale, Welfare and Recreation (FMWR) fitness centers, sports field complexes, and pools.

The proponent of this policy is the Directorate, Family and Morale, Welfare and Recreation.

This policy is effective immediately. It remains in effect until rescinded or superseceded.

Applicability: These requirements and procedures are applicable to all United States Forces Korea (USFK) military, Department of Defense Civilians, Korea Augmentees to the U.S. Army (KATUSA), Korean Military Forces, Authorized Contractors, Technical Representatives, Korean National Personnel and their family members residing in or granted access to USAG-Humphreys and Area III, and all other interested parties not mentioned above.

Eligibility and Priority of Use.

U.S. Active Duty (AD), Reserve Component (RC), Retirees and their Family Members (Authorized up to 4 guests).

KATUSA Soldiers and other ROKA assigned to U.S. Military units. (No family members/guests authorized)

U.S. Civilian employees and their Family Members. (Authorized up to 4 guests)

SOFA status DOD contract personnel or technical representatives and their immediate Family Members. (Authorized up to 4 guests)

Korean Military Forces, and Korean National direct hire Civilian employees. (No family members/guests authorized)

Patrons eligible to escort guests must be at least 18 years old (17 if active duty).

- 7. Youth ages 16 and older may use all Physical Fitness Centers (PFC) and Indoor Pools with no supervision restrictions.
- a. Conditions for Youth ages 13-15 access.
- (1) May use Physical Fitness Centers as a guest of a parent or guardian and must be actively participating in the same activity and under direct line of sight supervision of parent/legal guardian or eligible sponsor at all times.
- (2) Must be a participant in a program, organized and conducted by Child and Youth Services, schools, or other authorized youth organizations. Organizations are responsible for ensuring all youth and others associated with their program are adhering to the facility/program rules; this includes ensuring that everyone checks in/signs into facilities and programs.
- (3) Youth ages 15 and under may use Indoor Swimming Pools as a guest of a parent or guardian and must be under direct line of sight supervision of parent/ guardian or eligible sponsor at all times.
 - b. Conditions for Children/Youth ages 12 and under access:

Must be a participant in a program, organized and conducted by Child and Youth Services, schools, or other authorized youth organizations. Organizations are responsible for ensuring all children/youth and others associated with their program are adhering to the facility/program rules; this includes ensuring that everyone checks in/signs into facilities and programs.

Parent/Guardian or sponsor is participating in authorized programs (i.e., Baby and Me Fitness, Stroller Shape Up, walking indoor track with baby in stroller). Children/infants inside or outside of strollers or other carriers are not permitted otherwise.

Children/infants strapped to individuals while using cardio/strength equipment is also prohibited.

Age-appropriate special events and spectator events. (i.e., intramural sports games days, swim meets)

AAFES concessionaire seating area at Collier Fitness Center IAW with Garrison Standards of Child Supervision policy.

Other approved programs and functions IAQ Garrison Standards of Child Supervision policy. (i.e., NEO exercises, flu shots, org days, unit functions)

(6) Children/Youth sitting on couches, hallways, aerobics rooms, weightrooms or other areas of fitness center while parent/legal guardian or approved sponsor is participating in activities (i.e., working out) is NOT considered active participation and will be asked to leave the facility.8. Eligible patrons may bring guest(s) into the fitness centers and indoor pools. Sponsors are required to sign their guest(s) in at the front desk and will remain with their guest(s) at all times while guest(s) are in the fitness center and/or pool facilities.

Guests are considered to be any unauthorized user of any age. This includes youth dependents who cannot access the facility on their own accord. Dependent youth are counted towards the maximum 10 guests when accessing a facility with their sponsor.

Dropping off guest and leaving them unattended to work out or other reasons is prohibited.

Exceptions to any guests count above 10 must be made with the respective facility manager.
