Federal Employees Dental and Vision Insurance Program (FEDVIP)

FEDVIP is voluntary dental and vision program available to retirees and their eligible dependents. If you recently retired, you have 60 days from your retirement date to enroll in a FEDVIP plan. After 60 days, you may only enroll during open season.

Open season will start on November 9, 2020 thru December 14, 2020. During this time you may enroll, cancel or change your dental and vision plan. There are ten dental and four vision plans to choose from. Be sure that your health care professional is a participating provider in the network to avoid out-of-pocket expenses for non-covered services.

If you have a qualifying life changing event (QLE), you are allowed to enroll or make changes to your FEDVIP plan within 60 days of the event. <u>Click here</u> to find about more about QLE.

To create your BENEFEDS account, visit <u>https://www.benefeds.com/</u>. Under Dental and Vision, select "Enroll". Once your account is established, you can manage your plan.

Shopping Privileges for Eligible Veterans

As of January 1, 2020, in-store shopping privileges at the commissary, Exchange and the use of Morale, Welfare and Recreation (MWR) facilities has been expanded to Purple Heart recipients, Former POW, veterans with service-connected disability and VA registered Caregivers of eligible veterans.

Eligible veterans must be enrolled in the VA health care system and have a Veteran Health Identification Card (VHIC) which is required to access military installation and to make purchases. Currently, VHIC is not issued overseas. More information about VHIC can be found at <u>https://www.va.gov/healthbenefits/vhic/</u>.

To start the process in Germany, eligible veterans must complete <u>AE Form 190-16A</u> and contact the nearest Installation Access Control Services to initiate their access. Once eligible veterans have been cleared to access the installation, they must contact and register with the <u>U.S.</u> <u>Customs Agency-Europe</u>. Forms must be completed and registered with the German Customs office and be issued what is known as the "Pink Card".

Veterans who are unable to shop due to a physical or medical condition may appoint their caregivers as a "Shopping Assistant" to shop on behalf of veterans. The same process applies and documents will be required. Family members of veterans and caregivers are not authorized to shop.

Further guidance for other European installations is still pending.

Attention All Group A Retired Beneficiaries!!

Starting on January 1, 2021, if you are a Group A retired beneficiary, you and your family must pay a monthly TRICARE Select enrollment fee to maintain your TRICARE Select coverage.

Here are the changes to the plan:

- Individual Plan: \$12.50 per month or \$150 annually
- Family Plan: \$25 per month or \$300 annually
- The catastrophic cap will increase from \$3,000 to \$3,500

Your enrollment fee will be waived, if you are:

- An active duty family member
- A survivor
- A medically retired retiree or family member

Later this year, you'll be asked to set up a monthly enrollment fee premium payment. These will be your option:

- If you receive your retirement or other pay from a military pay center, you will pay your TRICARE Select fees via a monthly allotment.
- If you don't get your retired pay through a military pay center, then you'll pay your fees by a recurring credit or debit card transaction. You can also pay your monthly fees through electronic funds transfer (EFT) from a US Bank.

You will be disenrolled from TRICARE Select for failure to pay enrollment fees by January 1, 2021. In case you miss the deadline, you will have 90 days from your last through date to request a reinstatement from your regional contractor.

2020 Thrift Savings Plan Contributions

Once you retire, you can no longer contribute to your TSP account however if you obtain federal employment, you are eligible to continue contributing.

Contribution limits for 2020 have been set to \$19,500. This applies to the total of traditional and Roth contributions. Participants age 50 and older may have a maximum catch-up contribution of \$6,500.

SBP-DIC Offset Elimination

The Defense Finance and Accounting Service (DFAS) is planning for the changes to the National Defense Authorization Act (NDAA) for fiscal year 2020 to phase-out the reduction of Survivor Benefit Plan (SBP) Survivor Annuities by amount of Dependency and Indemnity Compensation (DIC).

DFAS is currently conducting a legal review and analyzing how to implement the changes. Please do not call DFAS to inquire about your account or when you will receive your payment. Annuitants who are affected by the new law will see changes to their payment starting on February 1, 2021.

If you previously received a refund of SBP premiums paid due to the SBP-DIC offset, you DO NOT have to pay back the refund because of this change in the law.

It's very important that SBP annuitants have filed the correct mailing address with DFAS. If you do not have a myPay account, now would be the time to set up your account and create a profile.

Establishing a myPay account allows you to access your information at any time. You can download and print documents such as 1099-R and annuitant pay statement instantly. Address and banking information can also be update through myPay. It's fast and convenient and no need to fill out forms or wait on the phone to speak to a customer service representative. Survivor Benefit Plan for Child Annuitants

SBP annuity payments for children stop when they reach the age of 18, however full time-time students (in high school or at an accredited college or university) will continue to receive annuity payments until the age of 22 or otherwise become ineligible.

As of May 2020, the school certification form has been redesigned to be shorter, simpler and easier to file with DFAS. The <u>DD Form 2788</u>, Child Annuitant's School Certification, can now be certified each year instead of each term as previously required.

High school and college students turning 18 will receive a school certification form 60-90 days prior to their 18th birthday. The form must be filled out and signed by a parent or guardian and returned to DFAS prior to the first day of the month on the child annuitant's 18th birthday.

Students will self-certify and school official signature is no longer required. The Previous Attendance Letter will be used to certify past attendance. All forms can be upload to AskDFAS portal at <u>https://go.usa.gov/xymaH</u>.

Space-A Travel

As of 13 August 2018, a policy update took affect to allow eligible 100% disabled veterans to compete for Space-Available flights. Authorized veterans will be able to travel within the U.S. and its territories.

There is **<u>NO GUARANTEE</u>** that a seat will be available. All travelers must be prepared to purchase a commercial flight and other related expenses if Space-Available transportation is not available.

Registration: You can register in-person at your local AMC Passenger Terminal, fax or email your request.

There are 6 categories of eligibility:

Category I - Emergency Leave Unfunded Travel.

Category II - Accompanied Environmental and Morale Leave (EML) and accompanied family members

Category III - Ordinary Leave, Relatives, House Hunting Permissive TDY, Medal of Honor Holders, and Foreign Military.

Category IV - Unaccompanied Environmental and Morale Leave (EML).

Category V - Permissive TDY (Non-House Hunting), Students, Dependents, Post Deployment/Mobilization Respite Absence, and Others

Category VI - Retired, Dependents, Reserve, ROTC, NUPOC and Civil Engineer Corps members and 100% Disabled Vets.

Driving in Europe

ITALY:

Italy passed a law on November 7, 2019 requiring all drivers to have car seats with an alarm for children under the age of 4. The law was passed due to several fatal cases of children being accidentally left in the car in extreme heat. As of March 6, 2020, drivers who violate this law are subject to fines up to \notin 326 and five points on their driver's license. Repeated offenders will face suspended driving privileges for fifteen days. All registered vehicles in Italy, including rental cars, are required to use child safety seats.

If you don't have a new car seat equipped with an alarm, you may purchase alarms to be added to exiting car seats. Any travelers renting a car in Italy should inquire with the rental company regarding the availability of car seats with an alarm.

GERMANY:

As of April 28, 2020, Germany's new traffic rules has stiffer penalties. <u>CLICK HERE</u> to download the 2020 Fine Catalog in German (Translated version is not available) or visit <u>https://www.bussgeldkatalog.de/</u> for more information.

BEGIUM:

Each European country has different requirements of items that are required to be in your registered vehicle when driving.

In Belgium the following items are required for all registered vehicles:

- Reflective Jackets In the event of breakdown, accident or stopped vehicles in a prohibited area
- Warning Triangle
- Headlamp Bean Deflectors You may have a deflector sticker or adjust the beam manually
- First Aid Kit
- Fire Extinguisher

TRAVELING WITH PETS:

An European Union (EU) Pet Passport is a universal document that contains your pet's identification, ownership and medical information and required when traveling to any of the EU countries. This document is issued by an official veterinarian in a EU Member State or other designated country that contains official health information of your pet.

Some EU countries have additional vaccination requirements. Switzerland and Norway are not part of the EU countries but accept the EU Pet Passport.

If you are traveling to the U.S. with a pet, please visit the United States Department of Agriculture (<u>USDA</u>) website for more information. Not all animals qualify as pets. <u>Birds</u> have a stricter import requirement and are subject to quarantine.

It is also recommended that you scan or photocopy of your Pet Passport incase it's lost or stolen.







REAL ID Act

On December 20, 2013, the Department of Homeland Security (DHS) announced the implementation and enforcement plan for the REAL ID Act that was passed by Congress in 2005. The REAL ID Act set standards for the issuance of identification such as driver license and state identification card. In order to meet the Act requirements, you must provide required documents.

A REAL ID-compliant driver license and state ID with the "Gold Star" logo verifies proof of residence and identity for national security reasons. This will allow you to enter U.S. federal government facilities and is an accepted form of ID for domestic air travel within the U.S.

The deadline to comply with the REAL ID Act is October 1, 2020. After that date, you will need to have a REAL-ID compliant driver license or state ID with the "Gold Star" to access government facilities or fly domestically within the U.S. If your driver license or state ID is not REAL ID-compliant, you must use other forms of acceptable identification such as a U.S. Passports, enhanced Driver's License, or Permanent resident card.

To find out if your state is in compliance with the REAL ID Act log onto <u>https://www.dhs.gov/real-id</u> and select your state.



International Direct Deposit

International Direct Deposit (IDD) is available to U.S. military retirees and annuitants living in an eligible location overseas. Please visit <u>https://www.dfas.mil/retiredmilitary/manage/idd.html</u> for a listing of eligible countries.

If you are planning to change your direct deposit, ensure the funds have been deposited into your new account before closing the old account. IDD is secure, safe and convenient. Mailed checks can be lost in the mail or stolen.

Your payment will be converted from U.S. dollars to the local currency using the wholesale exchange rate two days prior to the payment date to your local bank.

To start your IDD, you must complete SF 1199-I, <u>International Direct Deposit Enrollment</u> form and submit to DFAS. The form is fillable and it's recommended to type your information and don't forget to sign the document. Joint account holders must have both signatures.

Federal Benefits Unit

The Federal Benefits Unit (FBU) administers federal benefits programs for the Social Security Administration, Department of Veterans Affairs, Office of Personnel Management, Railroad Retirement Board, and Department of Labor.

Reporting changes to the Social Security Administration (SSA). There are 13 things that you MUST report to the SSA:

- 1. Change of Address
- 2. Work outside of the U.S.
- 3. If your disability improves, or your return to work, after qualifying for disability benefits
- 4. Marriage
- 5. Divorce or annulment
- 6. Adoption of a child
- 7. Child leaves the care of a spouse or surviving spouse
- 8. Child nearing age 18 is a full time student or disabled
- 9. Death
- 10. Inability to mange funds
- 11. Deportation or removal from the U.S.
- 12. Changes in parental circumstances
- 13. Eligibility for a pension from work not covered by Social Security

How to report your changes:

You can report by contacting the FBU or the Social Security Administration. Be sure to include the following when reporting:

- The name of the person or persons about whom the report was made
- What is being reported and the date it happened
- The claim number (a nine-digit number followed by a letter or a letter and a number) or BNC# that appears on correspondence from SSA.

Oven Roasted Asparagus

- 1 bunch thin asparagus spears, trimmed
- 3 T. Olive oil
- 1 1/2 T. Grated parmesan cheese
- 1 clove garlic, minced
- 1 t. sea salt
- 1/2 t. ground black pepper
- 1 T. lemon juice
- 1. Preheat oven to 425 degrees F (220 degrees C
- 2. Please the asparagus into a mixing bowl, and drizzle with the olive oil. Toss to coat the spears, then sprinkle with Parmesan cheese, garlic, salt, and pepper. Arrange the asparagus onto a baking sheet in a single layer.
- 2. Bake in the preheated oven until just tender, 12 to 15 minutes depending on thickness. Sprinkle with lemon juice just before serving.
