- BK.015, Exemption from Application of the Service Contract Labor Standards to Contracts for Maintenance, Calibration, or Repair of Certain Equipment- Certification.
- BK.016, Exemption from Application of the Service Contract Labor Standards to Contracts for Certain Services-Certification.
- BK.017, Compliance with Veterans' Employment Reporting Requirements.
- BK.022, Representation Regarding Certain Telecommunications and Video Surveillance Services or Equipment.
- BK.025, Covered Telecommunications Equipment or Services-Representation.
- BK.027, Representation by Corporations Regarding Delinquent Tax Liability or a Felony Conviction under any Federal Law.
- BK.030, Certification Regarding Knowledge of Child Labor for Listed End Products.
- BK.032, Disclosure of Ownership or Control by the Government of a Foreign Nation.

(d) *Annual Recertification Requirement.* For the duration of this award, the Offeror/Contractor shall annually recertify the applicable Section K provisions listed in paragraph (c).

(e) *Changes.* If any Section K information changes, the Offeror/Contractor must submit updated, signed versions of the affected provisions to the Contracting Officer prior to the annual modification.

(f) *Scope of Changes.* Any changes submitted by the Offeror/Contractor apply only to this NAF award and do not update your profile on SAM.gov. Offeror/Contractor shall manage both records separately, as the NAFI does not revise Section K based on SAM.gov profiles.

(g) *Enforcement.* Failure to provide accurate initial certification and annual recertification or to notify the Contracting Officer of material changes may render the Offeror/Contractor non-responsible and subject to award termination.
