## Service Member Participation and Eligibility

Service Members are authorized to participate in **one** Career Skills Program during their **last 180 days in the Service (not to exceed 120 days without HQDA G1 authorization)**. They can either participate in a CSP, DoD SkillBridge Program, or an Individual Internship Program. The CSP is a Commander's program and a Service Member's **participation in a CSP must be approved by the first field grade officer with UCMJ authority in the Soldier's chain of command.** 

Service Member must be within 180 days of their separation/retirement date
Service Member must have completed TAP Career Readiness Standards requirements.
Service Member must have Commander and Legal approval.
Service Member enrolled in IDES or assigned to Soldier Recovery Unit (SRU) may begin a CSP immediately following their Medical Retention Determination Point (MRDP)
Programs may have additional requirements.

Planning must include sufficient time after completion of CSP to return to your unit/permanent duty station to complete physical and administrative out-processing requirements in accordance with AR 600–8–101, to include unit-level and installation level out-processing and final out before a separation or retirement date

## Types of CSP

## **Army Approved CSPs:**

Programs that have already been vetted and received approval by HQ IMCOM, G-1 or HQDA G-1 for Service Member participation at one or more Army installations. These are garrison commander approved programs in which the approved Army CSP providers sign an Installation MOU/MOA. Visit the CSP Locations Page for more information and a list of programs.

## DoD SkillBridge Programs:

Programs in which the DoD establishes a MOU/MOA with industry partners to provide Service Members opportunities in a variety of fields, such as energy, information technology, manufacturing, retail, transportation, civil service and more. These programs are not vetted or approved by HQ IMCOM, G-1 and require a SJA legal review.

## Individual Internship Programs:

Service Members are required to locate the company, explain the CSP program to the company, and get the private company to agree to participate in the program. Individual internships are a good fit for Service Members who want to pursue careers in a desired field or with a specific company/organization for which the CSP does not have a current approved program. These programs are not vetted or approved by HQ IMCOM, G-1 and require a SJA legal review.

# **Become A Fort Liberty**Career Skills Program (CSP)



CSP provides Service Members with the opportunity to participate in career and employment skills training opportunities during their last 180-days on active duty (not to exceed 120 days). The program is authorized by Department of Defense Instruction (DoDI) 1322.29 and Army Regulation (AR) 600-81, Chapter 8.

Providers must meet CSP requirements in order to become an approved program. Garrison Commanders have the authority to decide which programs are associated with their garrison. The HQs IMCOM G1 is the vetting and approving authority for a CSP.

In order to streamline the process, please provide the following information in a LOI on Company Letterhead. The LOI must include at a minimum:

- 1. Company training provider name
- 2. Company/Companies who will hire program graduates
- 3. Company/Provider Point of Contact (POC)
  - a. Name
  - b. Phone Number
  - c. Email Address
- 4. Description of program
- 5. Type of training (Internship/Apprenticeship/On-the-Job Training/Employment Skills Training)
- 6. Proposed training program location/Army Installation
- 7. Training length (number of weeks)
- 8. Training cost and funding source (indicate any expenses the company/provider will NOT cover)
- 9. Proposed program start date
- 10. Army resources required (classroom, computers, etc...)
- 11. Salary range
- 12. Company/Provider commitment to 85% Graduation Completion Rate, 100% Interview Rate of program graduates, and 90% Placement Rate of those interviewed
- 13. Explain the training benefits for Transitioning Soldiers participating in the program
